**PROPOSED REGIONAL BUDGET POLICY**

The attached table is for information of the 45th Directing Council, 56th session of the Regional Committee for the Americas, and will not form part of the proposed Regional Program Budget Policy as presented. The table illustrates an indicative revised distribution of regular budget resources according to the proposed model, and it uses the approved country allocation for the 2004-2005 biennium as a comparison.
