#### **MARIA NEIRA**

Director, Public Health and the Environment Department, World Health Organization (WHO)

Dr Neira is the Director of the Department of Public Health and Environment at the World Health Organization (WHO). Previously, between September 2002 and August 2005, she was President of the Spanish Food Safety Agency and Vice Minister of Health and Consumer Affairs in Spain. Dr Neira was appointed in 1999 as Director of the Department of Control, Prevention and Eradication at WHO. Prior to that, Dr Neira had been working for WHO in Geneva since 1993, as Coordinator of the Global Task Force on Cholera Control.

Before joining WHO, Dr Neira worked as Public Health Adviser in the Ministry of Health in Mozambique from 1991 to 1993. Earlier, in Kigali,

Rwanda, she was a UN Public Health Advisor/Physician on assignment from the United Nations Development Programme (UNDP). From 1987 to 1989, Dr Neira was in Salvador and Honduras as Medical Coordinator for Médecins sans Frontières. Dr Neira started her professional career with three years in endocrinology and nutrition in the Necker Hospital and Hôpital Saint Louis in Paris from 1984 to 1987.

Among other distinctions, Dr Neira has been awarded the Médaille de l'Ordre national du Mérite by the Government of France.

He joined CNNMéxico.com after working for three years as the editor in chief of *CNNExpansión.com*, an economic information site created in 2007 by CNN and Grupo Editorial Expansión.

For six years, he served as the co-editor and journalist of the newspaper *Reforma*, where he was in charge of the coverage on macroeconomic information and multilateral and financial organisms.

As a journalist, he collaborated between 1994 and 2000 with newspapers and journals such as *El Financiero*, *Siglo 21* and *Público*, and with international news agencies like *Reuters* and *Agence France-Presse*.

During his 15 years of professional experience, he has interviewed important personalities like Nobel Prize in Economics, Joseph Stiglitz; President and CEO of General Electric, Jeff Immelt; Mexican businessman Carlos Slim Helú and former secretary of treasury, Robert Rubin.



He has covered special events such as the World Economic Forum in Davos, and International reunions in the UN, the Inter American Development Bank, the Group of Rio and the Asia Pacific Economic Cooperation (APEC).

He was selected by the Balboa Program of Latin American Journalists in 2003 to work on an academic and work internship in Madrid, where he worked as a journalist and editor for the Spanish economic Journal *Cinco Días*.

Armando graduated from the Communications School at the University of the Atemajac Valley in Guadalajara. He received a seminary on Precise Journalism at the Autonomous University of Madrid/El Pais in Spain and he received a diplomat on economic and enterprises given by the Center of Economic Teaching and Research (CIDE).
