REPORT ON THE COLLECTION OF QUOTA CONTRIBUTIONS

- 1. The Director has the honor of presenting a report on the status of quota contributions as of 31 July 2010. Collections are shown by Member State and date of payment.
- 2. Total contributions received as of 31 July 2010 were US\$79,405,269, compared to \$53,152,203 and \$41,125,176 received during the same periods in 2009 and 2008, respectively. Of the amount received this year, \$54,061,122 is related to 2010 assessments and \$25,344,147 to assessments for prior years.
- 3. The balance of quota contributions still pending as of 31 July 2010 is \$51,320,464; it is comprised of \$44,263,878 in assessments for the current year and \$7,056,586 in assessments for prior years.
- 4. In response to Directing Council Resolution CD46.R8, Proposed Program Budget of the Pan American Health Organization for the Financial Period 2006-2007, five Member States have made voluntary contributions to the trust fund established to support the priorities identified in the alternate budget scenario contained in Official Document 317 presented at the 46th Directing Council. As a result, the total income received as of 31 July 2010 for the trust fund Voluntary Contributions for Priority Programs is \$236,505. The Priority Programs are: Surveillance, Prevention and Management of Chronic Diseases; Mental Health and Substance Abuse; Tobacco; Making Pregnancy Safer; HIV/AIDS; and Direction. Total funds disbursed or obligated to date come to \$234,058, leaving an uncommitted balance of \$2,447.
- 5. With funds made available through the Voluntary Fund for Priority Programs, the Organization provided support as follows:
- The Partners Forum for Action on Chronic Disease was launched in December 2009 in Washington, D.C. It was created as a catalyst for multisector partnerships

that drive direct social, environmental, and policy action to promote health and prevent chronic diseases. Regionwide participation included more than 130 individuals representing governments and ministries of health, academic and scientific research institutions, businesses, nonprofit organizations, and international organizations.

- Training for partnership and advanced negotiation for strategic engagement was provided through a course given in May 2009. The 23 participants included representatives from PAHO Representative Offices, ministries of health, and regional advisors. This course served to develop skills and awareness through multistakeholder consensus building, face-to-face negotiation exercises, current and anticipated negotiation strategy clinics, and personal and organizational negotiation capacity building.
- The preparatory meeting for the Economic and Social Council (ECOSOC) session on HIV and development initiatives took place in June 2009. Twenty Latin American and Caribbean countries were represented, as well as a number of NGOs and other international organizations. The focus of the discussions was how to ensure the sustainability of existing responses to HIV, such as expanding access to treatment, in the light of competing health agendas, new challenges, and impact of a global financial crisis. The document produced by the meeting served as a blueprint for the recommendations that were later presented in Geneva.
- Subregional advisors provided technical cooperation in the field of mental health and substance abuse to the two subregions the Central American countries, Mexico, and the Latin Caribbean (Cuba and the Dominican Republic) and the English-speaking Caribbean. This support at the subregional level strengthened technical cooperation with the countries, especially in priority areas and care to vulnerable groups.
- 6. To provide the 50th Directing Council with the latest information on contributions, an updated status report will be issued prior to the meeting.
- 7. The 146th Session of the Executive Committee considered the status of quota contributions and the special report of the Director on Member States in arrears in an amount exceeding the sum of their quota assessments for two full years and adopted Resolution CE146.R1 (Annex B).

RESOLUTION

CE146.R1

COLLECTION OF QUOTA CONTRIBUTIONS

THE 146th SESSION OF THE EXECUTIVE COMMITTEE,

Having considered the report of the Director on the collection of quota contributions (Document CE146/23 and Add. I), including a report on the status of the trust fund entitled *Voluntary Contributions for the Priority Programs: Surveillance, Prevention, and Management of Chronic Diseases; Mental Health and Substance Abuse; Tobacco; Making Pregnancy Safer; HIV/AIDS; and Direction;*

Noting that there are no Member States in arrears in the payment of their quota contributions to the extent that they can be subject to the application of Article 6.B of the Constitution of the Pan American Health Organization;

In view of the significant reduction in arrears of contributions such that there are no outstanding amounts due prior to the 2008-2009 biennium;

Noting that there are 22 Member States that have not made any payments towards their 2010 quota assessments,

RESOLVES:

- 1. To take note of the report of the Director on the collection of quota contributions, including a report on the status of the trust fund entitled *Voluntary Contributions for the Priority Programs: Surveillance, Prevention, and Management of Chronic Diseases; Mental Health and Substance Abuse; Tobacco; Making Pregnancy Safer; HIV/AIDS; and Direction.*
- 2. To commend the Member States for their commitment in meeting their financial obligations to the Organization by making significant efforts to pay their outstanding arrears of contributions.
- 3. To thank the Member States that have already made payments for 2010 and to urge the other Member States to pay all their outstanding contributions as soon as possible.
- 4. To request the Director to continue to inform the Member States of any balances due and to report to the 50th Directing Council on the status of the collection of quota contributions.
