Disseminating Screening and Brief Interventions in Primary Health Care
The Experience in Brazil

A model program for wide dissemination of *brief interventions* is being implemented in Ribeirão Preto, Estado de São Paulo. Coordinated by Dr Erickson Furtado, from the Department of Psychiatry at the State University of São Paulo, the program has received initial support from the World Health Organization -WHO- and now runs independently, in collaboration with the State of São Paulo's Health Department.

The program trains primary care professionals in the use of the "Alcohol Use Disorders Identification Test" -AUDIT- and provision of brief interventions. Health professionals come mostly from programs of family health and work at primary health care centers (Unidades Básicas de Saúde- UBS). The Secretary of Health funds the partnership (since 2006 with permanent staff). Since 1999, they have trained about 400 health professionals plus 200 health administrators; training is conducted on average twice a month, for about 25 health professionals each time. The professionals are usually referred by the municipality. The Department of Psychiatry provides regular supervision, organizes seminars or conferences to keep the topic of excessive alcohol use "alive", and collaborates with mental health and HIV/AIDS/STD units of the Health Department. Trained professionals are then followed up on how many screenings and interventions they do, with focal groups discussions. They also work with health administrators to assess how they respond to alcohol problems and identify barriers and opportunities to incorporate the intervention in health centres.

The program plans to cover 25 municipalities, of which 6 are already active: Ribeirão Preto, Batatais, Altinópolis, Cássia dos Coqueiros and Santa Cruz da Esperança. They provide supervision to other regions of São Paulo state too. Most of the program is run with local resources from the municipalities. While there are other attempts to integrate *screening and brief interventions* in Brazil, this comprehensive program can be seen as a model which can be adapted to other countries in the region. The program is not only providing training but also supervision, advocacy around alcohol related topics, links to mental health services and evaluation of training. Furthermore, it is working in a real partnership with the health authorities from the different municipalities.

News from PAHO's Technical Cooperation Program in Panama and Cuba

Dr. Marcia Basaco and Dr. Alejandro García - from Cuba- took part in the National Workshop organized to discuss the reformulation of Panama's Mental Health Plan and shared their expertise in the field of child and youth mental health and community mental health respectively.

Professionals from all over the country participated in the Workshop and discussed the priorities in the field of mental health for the next three years. They also laid the basis for the development of a Mental Health Program based on primary care, which will be implemented, as a local experience, in the Municipality of San Miguelito, Province of Panama.

Two experts from Panama will be soon visiting Cuba to share their own experiences: Dr. Yadira Boyd, specialist in alcohol and substance abuse programmes, and Dr. Edgar Guerrero, as the coordinator of the experience in San Miguelito.
