#### Introduction

Over the last decade, increasing theoretical and political emphasis has been placed on the issue of gender and its effects on both women and men's social, economic, and cultural development. Though "gender" as a theoretical and methodological concept has been studied for somewhat longer, it is only recently that international, national and local development agencies, organizations, and institutions have begun trying to operationalize gender. Operationalizing gender means finding a way to move from the theoretical/academic debate about women and men, femininity and masculinity, to actually measuring the concrete effects of gender on women and men's development, and finding a way to redress inequities and inequalities which arise as a result of unequal gender roles and relations.

The process of operationalizing gender – making the theoretical practical – in international development is generally referred to as gender mainstreaming "...the process of assessing the implications for women and men of any planned action, including legislation, policies or programmes, in any area and at all levels 1..."

The primary objective behind gender mainstreaming is to design and implement development projects, programmes and policies that:

- a. do not reinforce existing gender inequalities between women and men
- b. attempt to redress existing gender inequalities between women and men
- c. attempt to redefine gender women and men's gender roles and relations

The degree of integration of gender in any given project, programme or policy can be conceptualized as a continuum

This annotated bibliography is an attempt to bring together existing resources (reports, manuals, guidelines etc.) on mainstreaming gender in health projects, programmes and policies. The primary intended audience is the staff of the Pan-American Health Organization, but the list of resources in this document can be useful to any health programmer who is trying to integrate a gender perspective into her work.

The resources are organized into five major areas: Introductions to Gender; Gender Policies, Plans and Commitments; Gender Mainstreaming Manuals and Guides; Gender Analysis Tools and Guidelines; and Gender and Specific Health Topics, which lists gender mainstreaming resources according to specific health areas (such as reproductive health or communicable diseases).

It begins by explaining why it is important to include a gender perspective in PHN programs, goes on to provide context-specific definitions of gender and associated terms, and concludes by proposing a framework for identifying and addressing potential gender-related obstacles to achieving project objectives.
