## Innovation for health: A new perspective

he Pan American Health Organization/ World Health Organization (PAHO/WHO) works actively to promote innovation in health technologies. Intrinsically linked with innovation is the goal to improve access to essential medicines, biologicals and diagnostics in the Region. To better achieve this goal, PAHO/WHO has developed the Regional Platform on Access and Innovation for Health Technologies.

This Platform is composed of a series of virtual tools designed to support and promote technological innovation, access, rational use, regulation, and governance of health technologies from the public health perspective. PAHO/WHO expects the platform to facilitate the development of linkages between stakeholders in health innovation systems to move beyond institutional, country and sector boundaries.

The Platform will also serve as an instrument to channel reliable information for the development of health products that constitute a priority for the Americas. It will support the development of enabling environments for technological innovation and facilitate the strengthening of national health and regulatory capacity to ensure access to quality health technologies.

## Access and innovation for health: A regional platform

### Goal

he Platform offers a series of virtual tools that will promote and support innovation, access, rational use, quality and governance in the area of medicines and health technologies from a public health perspective and to serve Regional health priorities.

### Scope

- Access to essential medicines and other health technologies.
- Quality and regulation of health technologies.
- Research, development and technological innovation for health.
- Rational use of health technologies.
- Health technologies and technological innovation for health governance and policies.
- Intellectual property management in public health.

## Expected results

The Platform is a dynamic instrument centered on member countries' public health needs. This tool facilitates networking, collaborative projects and the development of competencies in the health technology and innovation sector. Communication and collaboration between authorities, academia, civil society, the manufacturing sector and other parties with an interest in improving access to health technologies will:

- Strengthen the regulatory and governance functions of national health authorities in the health technologies and innovation for health sectors.
- Promote access to essential medicines and other health technologies and improve the rational use of these products based on the best available evidence.
- Facilitate the exchange of reliable information to support regulation, quality and use of health technologies.
- Promote technology transfer, manufacturing and innovation of health technologies designed to serve Regional health priorities.

## A platform promoting collaboration between Member States

he Regional Platform on Access and Innovation for Health Technologies is linked to the tradition of cooperation between countries in the Region. The Platform was developed with the support of member countries in collaboration with regional and international partners. Framed within the priorities specified in the Health Agenda for the Americas, the Platform will support the implementation of specific mandates including:

Access to Medicines (CD45.R7).

 Global Strategy and Plan of Action on Public Health, Innovation and Intellectual Property (GSPoA) (WHA61.21) and The Regional Perspective (CD48.R15).

 Strengthening National Regulatory Authorities for Medicines and Biologicals (CD50.R9).
