AMENDMENT TO THE STAFF REGULATIONS OF THE PAN AMERICAN SANITARY BUREAU

1. In order to improve the working methods of PAHO's Governing Bodies by rationalizing and streamlining their agendas, the Executive Committee at its 150th Session recommended that the determination of the salary of the Director of the Pan American Sanitary Bureau (PASB) be delegated from the Pan American Sanitary Conference/Directing Council to the Executive Committee (Resolution CE150.R2).

Amendment to Staff Regulation 3.1

2. In view of the above, the Executive Committee also recommended (Resolution CE150.R16) that Staff Regulation 3.1 be amended in order to provide that the salary of the Director of PASB be determined by the Executive Committee (see Annex A).

Action by the Pan American Sanitary Conference

3. In accordance with Staff Regulation 12.1 and as recommended by the 150th Executive Committee, the Conference is requested to consider the resolution in Annex B to amend Staff Regulation 3.1.
