Chile - Dental Students (3<sup>rd</sup> Year Students Only) Global Health Professions Student Survey (GHPSS)

FACT SHEET

The Chile Dental students GHPSS includes data on prevalence of cigarette smoking and use of other tobacco products, knowledge and attitudes about tobacco use, exposure to secondhand smoke, desire for smoking cessation, and training received during Dental school regarding patient counseling on smoking cessation techniques. This information could be very useful in monitoring and developing Chile's comprehensive tobacco control program. The Chile Dental students GHPSS was a census of 3<sup>rd</sup> year Dental students attending the 22 Dental schools in Chile that was conducted in 2008. The school response rate was 90.9% and the student response rate was 79.4%. A total of 792 students participated in the Chile Dental students GHPSS.
