Workshop on Mental Health and International Human Rights Standards

The National Magistrates, the Association of Lawyers of the City of Buenos Aires and PAHO/WHO, sponsored the Workshop: "Mental Health and Human Rights: Application of the International Standards" in Buenos Aires, Argentina, 26-28 March 2008. It had the sponsorship of the Ministry of Health of Argentina, the Ministry of Justice, the Ministry of Foreign Affairs, the Inter-American Commission on Human Rights (IACHR), the Collaborating Center of PAHO/WHO Human Rights and Washington College of Law (The American University, Washington DC).

The opening was held in the Supreme Court of Argentina. The President of the Court, Dr. Ricardo Luis Lorenzetti, considered the importance of the topic and of two recent decisions made by the highest court in Argentina on international human rights law for persons with mental disorders. In that session Dr. Lawrence Gostin, Director WHO Collaborating Center/PAHO, discussed the applicable human rights standards and explained some decisions of the European Court of Human Rights in this regard. Dr. Jose A. Pages, Representative of PAHO/WHO in Argentina, intervened in the opening offering the perspective of PAHO in this subject.

It was pointed out in the presentations that the interrelationship between human rights and health is a necessary condition for exercising the rights, but at the same time the effective exercise of the rights promotes a higher state of well-being and mental/physical health. It was also stated that it is essential that the plans, programs, budgets, and laws be based on human rights standards, considering that on average only 3% of the health budget in the region is directed to the area of mental health.

Finally, the use of human rights the instruments was key in recent cases decided by the Supreme Court in Argentina, by the European Court of Human Rights and by the Inter-American System of Human Rights.

On the last day were presented the conclusions and final recommendations. Among the conclusions it was pointed out the proposal of conforming a national commission for the formulation of mechanisms to shift those practices and regulations that hinder the effectiveness of the international human rights standards.

Workshop National on Evaluation of Mental Health Care (WHO-AIMS) Dominican Republic

On 3 April, in Santo Domingo the report on the evaluation of the mental health care in the Dominican Republic carried out with WHO-AIMS instrument was submitted. The report was presented by Dr. José Mieses, Director of the National Program of Mental Health, to a large group of representatives of health, academic, professional, and citizen institutions, as well as to mental health professionals of the country. Subsequently a national workshop that permitted to assess the strengths and weaknesses of the system was developed. The debates were grouped into five subjects; 1. the model of care decentralized, 2. Mental Health Policies and DDHH, 3. the training of human resources, 4. the strengthening of Primary Care and 5. the improvement of the information systems.

The national program committed to developing an intervention strategy on the basis of the conclusions of the workshop.
