Public Consultation: Successful experiences in competencies development for Pharmaceutical Services based on Primary Health Care (PS/PHC)

Background

The Renewed Primary Health Care proposal presents a different perspective for the development of healthcare systems. It recognizes the current values: right to the highest attainable standard of health, equity and solidarity, the principles of social justice, sustainability, intersectorality, inter alia. It also proposes to adapt the strategy to the context and current mandates, mainly derived from the Millennium Development Goals (MDGs) and address the social determinants of health to achieve the highest level of health.

The initiative on PS/PHC began in late 2008 as part of the activities promoted by PAHO/WHO to strengthen the health systems in the Americas, when an interdisciplinary Regional Working Group on Pharmaceutical Services based on Primary Health Care (WG-PS/PHC), with specialists from several countries belonging to governments, universities, NGOs and PAHO/WHO was established. This WG developed the **Guidelines for the Development of PHC-based Pharmaceutical Services.** The document presents a conceptual framework as a basis for understanding and (re)organizing the elements of PHC-based pharmaceutical services. It is therefore the ideal to be achieved, which may be adapted in each country according to its conditions.

In 2010, this issue was discussed during the Pan American Conference on Pharmaceutical Education (CPEF). The International Pharmaceutical Federation (FIP) has been working with WHO for many years on the development of education and practice standards for the pharmacist. The most recent outcome of this partnership was the publication of the updated Good Pharmacy Practices (WHO Technical Report Series, No. 961, 2011), already translated into Spanish. The FIP also developed a draft "Framework for Core Competencies for Pharmacists". FIP and PAHO/WHO also support, since its inception in 1999, the Pharmaceutical Forum of the Americas (FFA), which congregates regional and national pharmaceutical associations and councils from the countries of the Americas, with the goal of strengthening the pharmaceutical practice in America's continent.

In 2011, the FFA with PAHO/WHO and FIP considered as one of the essential needs to identify the competencies required for the development of pharmaceutical services based on PHC and to develop implementation strategies as part of development of the PS/PHC. The initiative may also help to adjust and strengthen the Pharmacy curricula and expand opportunities for life-long learning and continuing education towards this direction. In that regard, in February 2012, a Working Group with representatives from PAHO/WHO, WG PS/PHC, FFA, FIP and CPEF was established for developing a proposal of competencies for pharmaceutical services based in PHC.

According to PAHO/WHO¹ competencies (e.g., knowledge, skills, and attitudes) are personal characteristics that become evident when a task is carried out or a job is performed. They are related to successful performance of an activity, work-related or otherwise". Whereas it may have different definitions of competencies and forms of development, we invite you to participate in this consultation.

Contributions to the consultation will be used in the development of the proposal on pharmacists competencies for the development of pharmaceutical services (SF) based on Primary Health Care (PHC) and Good Pharmacy Practice, as well as strategies for implementation of this proposal.
