FINAL REPORT

Opening of the Session

- 1. The 163rd Session of the Executive Committee was held at the Headquarters of the Pan American Health Organization (PAHO) in Washington, D.C., on 27 September 2018. The session was attended by delegates of the following nine members of the Executive Committee elected by the Directing Council or the Pan American Sanitary Conference: Barbados, Belize, Brazil, Canada, Colombia, Ecuador, Panama, Peru, and the United States of America. Delegates of Antigua and Barbuda and Mexico attended in an observer capacity.
- 2. Mr. Carlos Fernando Gallinal Cuenca (Brazil, Outgoing Vice President of the Executive Committee) opened the session and welcomed the participants, extending a special welcome to the new members elected by the recently concluded 56th Directing Council: Barbados, Ecuador, and the United States of America.

Procedural Matters

Election of Officers

3. Pursuant to Rule 15 of its Rules of Procedure, the Committee elected the following Member States to serve as officers for the period from September 2018 to September 2019 (Decision CE163[D1]):

President: Canada (Mr. Nicolas Palanque)

Vice President: Belize (Dr. Marvin Manzanero)

Rapporteur: Peru (Ms. Sofía Velázquez Portocarrero)

4. The Director of the Pan American Sanitary Bureau (PASB), Dr. Carissa Etienne, served as Secretary ex officio, and the Deputy Director, Dr. Isabella Danel, served as Technical Secretary.

Adoption of the Agenda (Document CE163/1, Rev. 1)

5. Pursuant to Rule 9 of its Rules of Procedure, the Committee adopted, without change, the provisional agenda prepared by the Director (Decision CE163[D2]).

Committee Matters

Election of Three Members to the Subcommittee on Program, Budget, and Administration

6. The Committee elected Belize, Brazil, and Peru to serve on the Subcommittee on Program, Budget, and Administration on the expiration of the periods of office of Antigua and Barbuda, Argentina, and Chile on the Executive Committee. The Committee expressed appreciation to Antigua and Barbuda, Argentina, and Chile for their service (Decision CE163[D3]).

Governing Bodies Matters

Proposed Dates for Meetings of the Governing Bodies of PAHO in 2019 (Document CE163/2)

- a) 13th Session of the Subcommittee on Program, Budget, and Administration
- 7. The Committee decided that the 13th Session of the Subcommittee on Program, Budget, and Administration would be held from 27 to 29 March 2019 (Decision CE163[D4]).
- b) 164th Session of the Executive Committee
- 8. The Committee decided to hold its 164th Session from 24 to 28 June 2019 (Decision CE163[D5]).
- c) 57th Directing Council, 71st Session of the Regional Committee of WHO for the Americas
- 9. The Director proposed that the 57th Directing Council, 71st Session of the Regional Committee of WHO for the Americas, should be held from 30 September to 4 October 2019. She noted that, in proposing the dates, the Bureau had taken account of the dates of the Seventy-fourth session of the United Nations General Assembly.
- 10. The Committee decided that the 57th Directing Council would be held from 30 September to 4 October 2019 (Decision CE163[D6]).

Proposed Topics for Meetings of the Governing Bodies of PAHO in 2019 (Documents CE163/3, Rev. 1, and CE163/4, Rev. 2)

- a) 13th Session of the Subcommittee on Program, Budget, and Administration
- 11. The Executive Committee considered the list of topics proposed for discussion by the Subcommittee on Program, Budget, and Administration during its 13th Session (Document CE163/3, Rev. 1). The Director noted that the proposed topics were those customarily considered by the Subcommittee. In 2019, those topics would include the draft

proposed PAHO Strategic Plan for 2020-2025, the outline of the Program and Budget for 2020-2021, and recommendations of the PAHO Budget Policy.

- 12. The Executive Committee endorsed the list of topics contained in Document CE163/3, Rev.1 (Decision CE163[D7]).
- b) 164th Session of the Executive Committee
- 13. The Director drew attention to Document CE163/4, Rev. 2, which contained the list of topics proposed for discussion by the Executive Committee during its 164th Session, together with tentative lists of topics for discussion in 2020 and 2021. She noted that, in addition to the usual reports from the Audit Committee, the Office of Internal Oversight and Evaluation Services, and the Ethics Office, the first annual report of the new Investigations Office would be presented in 2019. The proposed program policy matters included a policy for an integrated approach toward the elimination of communicable diseases in the Americas, a plan of action for strengthening information systems for health, a strategy and plan of action on health promotion within the context of the Sustainable Development Goals, a plan of action on human organ donation and transplantation, a strategy and plan of action to improve quality of care in health service delivery, and a strategy and plan of action on ethnicity and health. In compiling the lists of topics, the Bureau had taken into account the need to allow sufficient time for the consultation processes required to produce mature documents for presentation to the Executive Committee and the Directing Council.
- 14. In the ensuing discussion, several delegates requested that a proposed plan of action to eliminate industrially produced trans-fatty acids, originally scheduled for consideration in 2020, should instead be considered in 2019. Clarification was sought of the approach to be taken and the intent and purpose of the proposed strategy and plan of action to improve quality of care in health service delivery, the plan of action on human organ donation and transplantation, and the communicable disease elimination initiative. In relation to the latter, a delegate inquired what role Member States would play in the initiative, noting that the description provided (in a separate, informal document circulated in the meeting room) appeared to suggest that the related document would be a corporate document for the Bureau only.
- 15. The Director explained that the Bureau staff believed that some communicable diseases represented "low-hanging fruit" and could be eliminated relatively quickly. It had even projected years by which some diseases could be eliminated. Of course, achieving that goal would not just be a responsibility of the Bureau. Engagement and commitment by Member States would also be required.
- 16. Dr. Marcos Espinal (Director, Department of Communicable Diseases and Environmental Determinants of Health, PASB) added that the Bureau had been working on the communicable diseases elimination initiative for the past year. The PASB Executive Management had approved a framework designed to accelerate the elimination of more than 20 communicable diseases, including several targeted for elimination under the 2030

Agenda for Sustainable Development. While the document would be a policy document, not a plan of action, the intent was to ensure that the Organization as whole—i.e., both the Bureau and Member States—would take the necessary action to accelerate elimination efforts. Elimination, as conceived of under the initiative, would comprise four dimensions: zero transmission, zero mortality, zero morbidity, and zero disability.

- 17. Dr. James Fitzgerald (Director, Department of Health Systems and Services, PASB) recalled that in 2017 a Member State had proposed, on behalf of the Latin American countries, the development of a plan of action on organ donation and transplantation. Since then, the technical unit responsible had conducted a series of consultations with Member States and had made good progress in drawing up the plan, the aim of which was to assist Member States in addressing the growing demand for organ transplants and to improve access to donated organs in a manner that complied with international standards and norms and ensured effective regulation.
- 18. With regard to the proposed strategy and plan of action to improve quality of care in health service delivery, he noted that existing mandates relating to quality of care, which focused mainly on patient safety, were outdated. The proposed strategy would look at the issue of quality from a regulatory and governance perspective in the context of efforts to achieve universal health and universal health coverage, the aim being to ensure real impact in terms of the delivery of quality health services in Member States. The strategy would also consider critical inputs that needed to be addressed in relation to quality, such as accreditation of human resources and matters related to the organization, administration, and management of health services.
- 19. Dr. Anselm Hennis (Director, Department of Noncommunicable Diseases and Mental Health, PASB) said that there was clearly a sense of urgency with regard to the elimination of industrially produced trans fats, as had been illustrated both by the Committee's comments and by the comments made during a side event on the topic held during the recently concluded 56th Directing Council. He noted that the Trans Fat Free Americas declaration, adopted in Rio de Janeiro in 2008, had yielded limited results. If the proposed plan of action was to produce noticeable progress, it was important to ensure that it was not launched until it was sufficiently mature.
- 20. The Director said that if Member States wished to see the plan of action launched in 2019, the Bureau would do its best to prepare the plan for consideration by the Executive Committee at its 164th Session.
- 21. The Committee endorsed the list of proposed topics contained in Document CE163/4, Rev. 2, with the addition of the plan of action to eliminate industrially produced trans-fatty acids to the program policy matters to be considered in 2019 (Decision CE163[D8]).

Other Matters

22. The Director noted that the Bureau had recently issued a press release aimed at dispelling any rumors that there had been a reemergence of poliomyelitis in the Region.¹ The last case of wild poliovirus in the Americas had been reported in 1991.

Closure of the Session

23. Following the customary exchange of courtesies, the President declared the 163rd Session closed.
