A. SIXTY-FOURTH WORLD HEALTH ASSEMBLY

- The 64th World Health Assembly opened in Geneva on 16 May 2011, with 1. representatives and delegates from 193 Member States in attendance. In her address to the Assembly, Dr. Margaret Chan, Director-General, noted the importance of remembering the people and pointed out that all the debates and discussions have meaning only when they improve the health of people and relieve their suffering. In this regard, she highlighted the advances in areas such as tuberculosis, HIV/AIDS, the improvement in child health thanks to vaccines, preparations for pandemic influenza, the progress made in the ministerial conferences preparatory to the High-Level Meeting on Noncommunicable Diseases to be held in the United Nations General Assembly, and the agreements reached by the Commission on Information and Accountability for Women's and Children's Health, among other issues. She also stressed the challenges that we face in an increasingly complex world, such as the financial crisis, climate change, natural disasters, and violence. Furthermore, given the financial crisis and the challenges that continue to arise in the field she noted that the World Health Organization (WHO) has launched an administrative, financial, and management reform process and invited everyone to contribute to the effort.
- 2. The keynote speakers were Her Excellency Sheikh Hasina, Prime Minister of the Government of Bangladesh, who pointed to great strides made in her country, especially with respect to maternal mortality, which has fallen by 66% in 10 years, and Bill Gates, Co-Chair of the Bill and Melinda Gates Foundation, who thanked WHO and its Member States for their continuing leadership, recognized their work, and called for making this the Decade of Vaccines. He underscored that with greater investment in vaccines and immunization, 10 million deaths can be prevented by the year 2020 and called on all parties to joint efforts toward this end, in the awareness that global health is the cornerstone of global prosperity.
- 3. As first Vice-President of the 63rd World Health Assembly, the Minister of Health of El Salvador, Dr. María Isabel Rodríguez, opened the Assembly and addressed it in the name of the countries of the Americas. She emphasized the importance of the Regional High-level Consultation of the Americas on Noncommunicable Diseases and Obesity, held preparatory to the High-level Meeting of the United Nations General Assembly, where the impact of these diseases on our countries and the world was underscored. She also mentioned the Regional Consultation on progress toward universal access to HIV prevention, treatment, care and support in the Region and noted the progress made in this regard, urging governments, multilateral organizations, and international donors not to cut back on their cooperation, as it is essential for preventing setbacks in these areas. She also called on the Assembly to approve the launch of World Vaccination Week in 2012.
- 4. Finally, she acknowledged the work of the Organization and its impact on the health of nations. Notwithstanding, she noted that significant changes have been taking place in

international health: on the one hand, the progress made in the general call to align international cooperation with country priorities (Paris Declaration of 2005), and on the other, the scattering and fragmentation of governance in international health, with an increasing number of actors with their own priorities, and the waning of multilateralism, which is undermining national capacity for governance and the management of cooperation resources. Dr. Rodríguez issued a call for greater unity of thought and action, especially in the face of the global financial crisis, and a return to the Alma-Ata principles of equity, solidarity, and social justice. The fight for unity, mutual understanding, and solidarity among all the peoples of the world must be an integral part of the strengthening of multilateral organizations.

- 5. During the first plenary session, the World Health Assembly endorsed the candidacy of Dr. Christos Patsalides, Minister of Health of Cyprus, and elected him President of the 64th World Health Assembly. The five Vice-Presidents were then elected: the delegates of the Democratic People's Republic of Korea, Iran, Nigeria, Philippines, and Trinidad and Tobago. The Assembly then took up the following agenda matters:
- (a) Establishment of the Committee on Credentials, comprised of nine Member States, among them the delegates of Barbados and Costa Rica for the Region of the Americas.
- (b) The Agenda of the 64th World Health Assembly, which contained 20 items, the majority of them on health policy matters and the rest, on administrative, budgetary, and institutional matters. As in previous Assemblies, these matters were addressed in the committees and the plenary sessions. The World Health Assembly adopted 28 resolutions. - (c) The majority of these resolutions are especially relevant to both the Member States of the Region of the Americas and the Regional Office. Of particular interest are those concerned with the strengthening of nursing and midwifery; sustainable health financing structures and universal coverage; drinking water, sanitation, and health; mechanisms for cholera control and prevention; the High-Level Meeting on Noncommunicable Diseases; and the Millennium Development Goals, among others.
- 6. The Annex provides a summary of the respective resolutions.

Other Matters: Executive Board

- 7. The 129th Session of the Executive Board was held on 25 May. The Region of the Americas was represented by the delegates of Barbados, Canada, Chile, Ecuador, Mexico, and the United States of America.
- 8. The agenda of the 129th Session of the Executive Board (EB) included the report on the work plan and the report on the establishment of the Consultative Expert Working Group on Research and Development: Financing and Coordination, the item "The Future of Financing for WHO, " in addition to administrative, budgetary, and financial matters; staffing matters and other matters for information.
- 9. The Board adopted Decision EB129(8): WHO Reform for a Healthy Future, in which it decides to establish a transparent consultative process on the WHO reforms and requests the Director-General to prepare, by the end of June 2011, three concept papers on: governance of WHO, independent evaluation of WHO, and the World Health Forum. In reference to the Regional Committees, it requests that, based on the updated concept papers, they engage in strategic discussions regarding the WHO reform process. The Board decides to hold a special meeting in November 2011 to discuss outcomes of the consultative process and draft proposals prepared by the Secretariat or proposed by Member States. It also urges Member States to support and actively engage in the reform process.
- 10. Finally, the Board took note of the reports submitted and approved the date and place of the 65th World Health Assembly, among other matters for information. It was agreed that the 65th World Health Assembly would be held at the Palais des Nations in Geneva from Monday, 21 May 2012 to no later than Saturday, 26 May 2012. The Board decided, moreover, that its 130th meeting would begin on Monday, 16 January 2012, at WHO Headquarters in Geneva and conclude no later than Monday, 23 January 2012; that the 15th meeting of the Executive Board's Committee on Program, Budget, and Administration would be held on Thursday, 12 and Friday, 13 January 2012, at WHO headquarters and that its 16th meeting would be held on Thursday, 17 and Friday, 18 May 2012, at WHO headquarters in Geneva.

B. FORTY-FIRST REGULAR SESSION OF THE GENERAL ASSEMBLY OF THE ORGANIZATION OF AMERICAN STATES

- 13. This document presents the resolutions adopted during the Forty-first Regular Session of the General Assembly of the Organization of American States (OAS), held in San Salvador, El Salvador from 5 to 7 June 2011.
- 14. The session was attended by the ministers of foreign affairs of the Member States of the Americas and other official delegates. Also in attendance, were representatives of both the governments accredited as Permanent Observers and agencies of the Inter-American system, among them the Pan American Health Organization and the agencies that comprise the Summit Implementation Review Group. The Minister of Foreign Affairs of El Salvador was elected President of this regular session of the General Assembly.
- 15. The theme of this General Assembly was "Citizen Security in the Americas," the topic addressed by the heads of delegation in their presentations. In addition to the resolutions and declarations of this session, the General Assembly adopted the Declaration of San Salvador, which is presented as an Annex to this document (Annex B-1). This declaration is linked with the resolution adopted by 50th Directing Council entitled "Health, Human Security, and Well-being" CD50.R16 [2010].
- 16. The majority of the recommendations and resolutions had been discussed and agreed upon earlier by the Permanent Council. The items on which a consensus had not been reached or new items proposed by the Member States were discussed in the General Committee of the Assembly or in special working groups that met in parallel with the plenary meeting.
- 17. The resolutions of interest to the Governing Bodies of the Pan American Health Organization and related to its work as the specialized health agency of the Inter-American System have been selected (table attached).

DECLARATION OF SAN SALVADOR ON CITIZEN SECURITY IN THE AMERICAS

(Adopted at the fourth plenary session, held on June 7, 2011)

THE MINISTERS OF FOREIGN AFFAIRS AND HEADS OF DELEGATION OF THE MEMBER STATES OF THE ORGANIZATION OF AMERICAN STATES (OAS), gathered in San Salvador, El Salvador, at the forty-first regular session of the OAS General Assembly;

RECOGNIZING that peace, security, democracy, human rights, development, and cooperation are the pillars of the inter-American system and that they are interlinked and mutually reinforcing;

CONVINCED that all multilateral efforts and cooperation in the area of security must respect in full the principles of sovereignty, territorial integrity, political independence of states, and of non-interference in the internal affairs of states, in accordance with the Charter of the United Nations, the Charter of the Organization of American States, and international law, as well as take into account different perspectives with regard to threats to states' security and their priorities;

RECOGNIZING that the Declaration on Security in the Americas reiterates that the concept of security in the Hemisphere is multidimensional in scope, includes traditional and new threats, concerns, and other challenges to the security of the states of the Hemisphere, incorporates the priorities of each state, contributes to the consolidation of peace, integral development, and social justice, and is based on democratic values, respect for and promotion and defense of human rights, solidarity, cooperation, and respect for national sovereignty;

RECOGNIZING that with the adoption of the Commitment to Public Security in the Americas at the First Meeting of Ministers Responsible for Public Security in the Americas (MISPA I), held in Mexico from October 7 to 8, 2008, the member states expressed their political

will for and the priority of confronting crime, violence, and insecurity in a joint, mutually supportive, preventive, comprehensive, coherent, effective, and continuous manner;

RECOGNIZING ALSO the Consensus of Santo Domingo on Public Security in the Americas adopted at the Second Meeting of Ministers Responsible for Public Security in the Americas (MISPA II), held in the Dominican Republic from November 3 to 5, 2009;

REAFFIRMING that the Meeting of Ministers of Justice or Ministers or Attorneys General of the Americas (REMJA) and other meetings of criminal justice authorities are important and effective forums for promoting and strengthening mutual understanding, confidence, dialogue, and cooperation in developing criminal justice policies and responses to address threats to security;

RECALLING the rights enshrined in the Universal Declaration of Human Rights, in the American Declaration of the Rights and Duties of Man, in the American Convention on Human Rights, and in the International Covenant on Civil and Political Rights;

TAKING NOTE of the Report on Citizen Security and Human Rights prepared by the Inter-American Commission on Human Rights and presented by it in December 2009;

RECOGNIZING that public security is the duty and exclusive obligation of the state, strengthens the rule of law, and has as its purpose to safeguard the integrity and safety of persons and to protect the enjoyment of all their rights;

TAKING INTO ACCOUNT that citizen and community participation is essential in the promotion and sustainability of public security policies;

RECOGNIZING that public security conditions are improved through full respect for human rights and fundamental freedoms, as well as by means of the promotion of education, culture, health, and economic and social development;

RECOGNIZING furthermore the need to promote and strengthen long-term and comprehensive state policies for public security that guarantee the protection and promotion of human rights, with an emphasis on addressing the causes of crime and violence;

UNDERLINING the need to continue coordinating international measures in the area of natural disaster prevention, mitigation, and assistance, while encouraging community participation and strengthening domestic capabilities as well as those of competent risk management agencies;

REITERATING the commitment to promote, within the framework of the rule of law, a culture of peace and non-violence, which is understood as a set of values, attitudes, and modes of behavior based on respect for life, human beings, and their dignity, and which gives priority to human rights, ending of violence, and adherence to the principles of freedom, justice, democracy, solidarity, tolerance, and respect for diversity;

RECOGNIZING that crime and violence impair the social, economic, and political development of their societies;

CONSIDERING ALSO that, in the OAS Charter, the member states agreed that equality of opportunity, the elimination of extreme poverty, equitable distribution of wealth and income, and the full participation of their peoples in decisions relating to their own development are, among others, basic objectives of integral development;

RECOGNIZING the need to take action to bring about conditions for social, economic, political, and cultural development so as to promote social inclusion, reduce inequity and create opportunities for their people thereby contributing to the prevention of crime, violence, and insecurity;

REITERATING the commitment to address the challenges related to pandemics and natural and man-made disasters;

REAFFIRMING that states have a duty and responsibility to provide the humanitarian assistance necessary to protect the life, integrity, and dignity of their inhabitants in natural or man-made disasters:

CONSIDERING the importance of adopting policies, programs, and actions to prevent and confront crime, violence, and insecurity, including measures for the protection of vulnerable groups;

CONVINCED that elimination of violence against women in all its dimensions is an indispensable condition for their individual and social advancement and for their full and equal participation in society; as well as of the importance of including a gender perspective in security policies;

RECOGNIZING the importance of providing youth, particularly at-risk youth, with opportunities for and access to education, training, employment, culture, sports, and recreation, in order to prevent violence;

REAFFIRMING that prevention, punishment, and eradication of migrant smuggling, trafficking in persons and exploitation in all its forms, including sexual exploitation of women and minors, are obligations of the member states that should be addressed in accordance with the national and international legal instruments on such matters, and when appropriate, in partnership with civil society;

TAKING INTO ACCOUNT that transnational organized criminal activities can be used to finance and facilitate terrorism;

RECOGNIZING the importance of continuing to strengthen law enforcement and criminal justice capabilities;

RECOGNIZING ALSO the importance of mutual assistance in criminal matters and extradition in response to the preparation, planning, commission, execution, or financing of acts

of terrorism, as well as corruption and organized crime, in accordance with domestic law and international agreements;

CONSIDERING the importance of international cooperation for improving economic and social conditions and thereby strengthening public security;

REAFIRMING the importance of maintaining and strengthening bilateral, subregional, regional, and international cooperation on security-related matters,

DECLARE:

- 1. That it is their priority to continue directing their political will, efforts and actions to strengthen citizen security, as a component of public security, in their countries.
- 2. The obligation of states to develop and implement public policies in the area of public security within the framework of a democratic order, the rule of law, and observance of human rights, geared towards providing security and strengthening peaceful coexistence in their communities.
- 3. That public security policies must encourage measures for dealing with the causes of crime, violence, and insecurity.
- 4. That the individual is at the center of citizen security, understood as a component of public security, and should therefore be a key factor in the definition and implementation of ways to build more secure and sustainable communities and societies that conform to their aspirations for democracy and for socioeconomic and cultural development.
- 5. That public security policies require the participation and cooperation of multiple actors, such as individuals, government at all levels, civil society, communities, the mass media, the private sector, and academia in order to reinforce promotion of a culture of peace and non-violence and respond effectively and in a participatory manner to the needs of society as a whole.

- 6. The importance of strengthening the capacity of the state to develop comprehensive, long-term public security policies with a gender-based perspective, bearing in mind the needs of vulnerable groups, including the promotion and protection of human rights, and adapting, as necessary, the appropriate legal frameworks, structures, programs, operating procedures, and management mechanisms.
- 7. The need to continue implementing policies and measures in the area of prevention, law enforcement, rehabilitation, and reintegration into society, in order to ensure a comprehensive approach in combating crime, violence, and insecurity, for the purpose of enhancing public security.
- 8. The determination to design public policies and educational programs with a view to achieving a cultural transformation aimed at eradicating domestic violence.
- 9. The importance of continuing to foster measures to ensure that their populations have access to justice and to the protection afforded by an effective, transparent, and reliable criminal justice system.
- 10. The need to continue promoting prison systems based on respect for human dignity and human rights, including policies and practices geared towards rehabilitation and reintegration into society.
- 11. Their commitment to strengthen the links between development and security and, in this regard, foster increasing interaction between the areas of integral development and multidimensional security of the OAS.
- 12. The importance of maintaining and strengthening bilateral, subregional, regional, and international cooperation on security-related matters.

- 13. The commitment to reinforce inter-American partnership for integral development and to strengthen cooperation mechanisms and actions to urgently address extreme poverty, inequity, and social exclusion.
- 14. The need to continue coordinating international measures in the area of disaster prevention, mitigation, and assistance, while encouraging community participation and strengthening domestic capabilities as well as those of competent risk management agencies.
- 15. The need to continue strengthening bilateral, subregional, regional, and international cooperation mechanisms, in keeping with the principles established in the OAS Charter, to address, prevent, and combat, in a comprehensive and effective manner, transnational organized crime, illicit arms trafficking, trafficking in persons, smuggling of migrants, the global drug problem, money laundering, corruption, terrorism, kidnapping, criminal gangs, and technology-related crime, including cybercrime, as they may affect, in certain cases, social, economic, and political development and the legal and institutional order.
- 16. To instruct the Permanent Council to prepare, in consultation and coordination with the national authorities of the Meeting of Ministers Responsible for Public Security in the Americas (MISPA) and of the Meeting of Ministers of Justice or Other Ministers or Attorneys General of the Americas (REMJA), with the assistance of the General Secretariat, a draft hemispheric plan of action, to follow up on this Declaration of San Salvador, to be considered by the forty-second regular session of the General Assembly;
- 17. That they request the General Secretariat to seek adequate funding for the preparation of the draft hemispheric plan of action and to report to the General Assembly at its next regular session on steps taken to this end

- 21. The resolutions and agreements of interest to the Governing Bodies of the Pan American Health Organization and are related to its work as the specialized health agency of the Inter-American System have been selected (tables attached).

22. It should be noted that to formalize its work with the subregional integration entities, the Pan American Health Organization Program Budget 2006-2007 introduced a section on subregional programs (Official Document 317, Proposed Program Budget of the Pan American Health Organization for the Financial Period 2006-2007, approved by the Directing Council in CD46.R8 [2005]).

We hereby express our interest in developing instruments, as well as identifying and sharing experiences and good practices, in such areas as the creation of universal health systems, human resources development and management, information systems, and the use of new technologies.	All of these issues are closely related to the Health Agenda for the Americas and to the Organization's technical programs in the relevant areas (health services, health information, human resources for health, health and social determinants, medicines and biological products, gender equality and interculturalism, etc.).

The Council of Central American Ministers of Health (COMISCA) of the Central American Integration System (SICA) meets in regular session twice yearly in whatever country is the Chair *pro tempore*. The last meeting was held in Guatemala, which was Chair *pro tempore* for the first half of 2011. El Salvador is Chair *pro tempore* for the second half of 2011. The Ministers and Ministries of Health participate in this forum. PAHO/WHO participates in the regular sessions of the Council at the invitation of the Executive Secretariat of COMISCA, as it is the Region's leading organization on health issues and a provider of technical assistance to the thematic Technical Commissions (Human Resources, Health Surveillance and Information Systems, Regional Coordination Mechanism for HIV/AIDS, Chronic Diseases and Cancer, and Medicines). PAHO/WHO also has a permanent representative on the Executive Committee for the Implementation of the Health Plan of Central America and the Dominican Republic (CEIP) and on the Advisory Committee of the Commission on Health Surveillance and Information Systems. • Southern Common Market (MERCOSUR)

In MERCOSUR, meetings of Working Subgroup 11 (SGT 11) approve resolutions that are then sent to the Common Market Group (GMC) for consideration. The SGT 11 meetings also discuss proposed resolutions that are submitted for internal consultation and study resolutions that propose recommendations. This work is done in the several SGT 11 subcommittees (Health Care, Health Products, Health Surveillance). SGT 11 also deals with resolutions on national coordination. In general, the issues addressed relate to regulation and the harmonization of regulations. PAHO participates as a technical advisory entity on health. The most recent meeting of SGT 11, its 36th regular session, was held in Asunción, Paraguay, from 4 to 8 April 2011. The following resolutions were approved on that occasion and submitted for the consideration of the Common Market Group:

- (b) 03/10 Prohibition of the marketing of human milk in the States Parties of MERCOSUR

Amazon Cooperation Treaty Organization (ACTO)

The Heads of State of the ACTO Member Countries resolved to give the organization a "renewed, modern role as a forum for cooperation, exchange, knowledge, and a joint presence to address today's new and complex international challenges." The 10th Meeting of Ministers of Foreign Relations of the ACTO countries, the highest body of the Amazon Cooperation Treaty (ACT), approved the New Strategic Agenda 2012-2020.

The issues on this new strategic agenda include a Regional Health Management Initiative, whose implementation is the responsibility of the Health Coordination Office of the ACTO Permanent Secretariat. PAHO/WHO has been providing technical cooperation with the Coordination Office in connection with the health chapter of the new Strategic Agenda, and the preparation of a health situation analysis of the Amazon region. The objectives of the ACTO Regional Health Management Initiative are to support action to meet the Millennium Development Goals in the Amazon and coordinate with UNASUR/Health to avoid the duplication of efforts.
