This was due to the vision of a remarkable person (the one who called that mandatory Sunday meeting) one who would constantly announce the future...today...and together we would have to find ways to realize that vision. In his eyes, it had already happened, and slowly but surely the pieces built that picture of IMAI that already existed in his mind.

It is because of him, I stand before you today accepting this award for a programme that has changed and continues to change the health of our peoples. He is an inspiration to public health professionals globally. I wish to publicly thank the exceptional vision, the tireless work and constant encouragement of our Minister of Health, one who has my utmost admiration and respect, (and it's not because he is my wonderful boss): the Honourable Dr. Leslie Ramsammy.
