AMENDMENT TO THE PASB STAFF RULES

1. The 28th Pan American Sanitary Conference amended Staff Regulation 3.1 (Resolution CSP28.R___) to provide that, as of 21 September 2012, the Executive Committee, rather than the Conference or Directing Council, will determine the salary of the Director of the Pan American Sanitary Bureau (PASB). This new authority is in addition to the Executive Committee's current authority under Staff Regulation 3.1 to approve the salaries of the Deputy Director and Assistant Director.
2. In light of the aforementioned Resolution and in accordance with her authority under Staff Rule 020 to amend the Staff Rules of the PASB, the Director submits for confirmation to the Executive Committee the proposed deletion of Staff Rule 330.4. Staff Rule 330.4 provides that the salary of the Director of PASB is determined by the Pan American Sanitary Conference or the Directing Council.

3. The Executive Committee is requested to review the Amendment to the PASB Staff Rules contained in Annex A of this document and consider approval of the proposed resolution attached in Annex B.

AMENDMENT TO THE PASB STAFF RULES

THE 151st SESSION OF THE EXECUTIVE COMMITTEE,

Having considered the *Amendment to the PASB Staff Rules* submitted by the Director in Annex A to Document CE151/3;

Taking into account the actions of the 28th Pan American Sanitary Conference regarding the authority to approve the salary of the Director of the Pan American Sanitary Bureau (PASB);
