REPORT ON THE COLLECTION OF ASSESSED CONTRIBUTIONS

- 1. The Director has the honor to present a report on the status of assessed contributions due from Members as of 31 July 2016. Collections are shown by Member States, Participating States, and Associate Members and by date of payment (See Annex A).
- 2. Total contributions received as of 31 July 2016 were US\$ 66,395,890¹ as compared to \$79,179,824 and \$84,048,887 received during the same periods in 2015 and 2014, respectively. Of the amount received this year, \$30,474,259 relates to 2016 assessments and \$35,921,631 relates to prior years.
- 3. In order to provide the 55th Directing Council with the latest information, an Addendum will be issued prior to the Session providing an update on the status of assessed contributions.
- 4. The balance of assessed contributions that remain due as of 31 July 2016 totals \$80,250,520 and is comprised of \$71,918,244 in current year assessments and \$8,332,276 pertaining to assessments for prior years.
- 5. The Organization continues to encourage the Member States to make prompt payment of their outstanding assessed contributions to ensure the efficient and effective implementation of its programs. As of 31 July 2016, no Member State is in arrears such that it can be subject to Article 6.B of the PAHO Constitution.
- 6. The Executive Committee at its 158th session considered the status of assessed contributions and adopted resolution CE158.R1, attached (see Annex B).

PROPOSED RESOLUTION

COLLECTION OF ASSESSED CONTRIBUTIONS

THE 55th DIRECTING COUNCIL,

Having considered the report of the Director on the collection of assessed contributions (Documents CD55/19 and Add. I), and the concern expressed by the 158th Session of the Executive Committee with respect to the status of the collection of assessed contributions;

Noting that no Member State is in arrears such that it would be subject to Article 6.B of the PAHO Constitution,

RESOLVES:

- 1. To take note of the report of the Director on the collection of assessed contributions (Documents CD55/19 and Add. I).
- 2. To express appreciation to those Member States which have already made payments in 2016, and to urge all Members States in arrears to meet their financial obligations to the Organization in an expeditious manner.
- 3. To congratulate those Member States which have fully met their assessed obligations through 2016.
- 4. To compliment those Member States which have made significant efforts to reduce arrearages in assessed contributions from prior years.

- 5. To request the Director to:
- a) continue to explore mechanisms that will increase the rate of collection of assessed contributions;
- b) inform the Executive Committee of Member States' compliance with their commitment to pay their assessed contributions;
- c) report to the 29th Pan American Sanitary Conference on the status of the collection of assessed contributions for 2017 and prior years.
