SCALE OF ASSESSMENTS AND ASSESSED CONTRIBUTIONS OF THE MEMBER STATES, PARTICIPATING STATES, AND ASSOCIATE MEMBERS OF THE PAN AMERICAN HEALTH ORGANIZATION FOR 2019

Background

- 1. Article 24(A) of the Constitution of the Pan American Health Organization (PAHO) states that "The Organization shall be financed by annual contributions from Governments. The contributions from Member Governments shall be determined in conformity with Article 60 of the Pan American Sanitary Code" which states that "for the purpose of discharging the functions and duties imposed upon the Pan American Sanitary Bureau, a fund of not less than \$50,000 shall be collected by the Pan American Union, apportioned among the Signatory Governments on the same basis as are the expenses of the Pan American Union." By virtue of this article, Member States of the Pan American Health Organization are assessed at the same rate as Member States of the Organization of American States (OAS), formerly known as the Pan American Union.
- 2. In addition to Member States, PAHO membership includes Participating States and Associate Members which are not Members of the OAS. The Participating States are France, the Kingdom of the Netherlands, and the United Kingdom of Great Britain and Northern Ireland. The current Associate Members are Aruba, Curaçao, Puerto Rico, and Sint Maarten. The assessment rates of PAHO's Participating States and Associate Members are based on economic and population parameters of the relevant territories in the Americas.
- 3. In June 2017, the OAS General Assembly adopted a transitional quota scale of assessments for the 2018 financial period, while its Committee on Administrative and Budgetary Affairs continued to review the OAS' current quota system and methodology.
- 4. In September 2017, the 29th Pan American Sanitary Conference approved the PAHO adapted scale of assessed contributions for the 2018 financial period, based on the transitional scale adopted by the OAS General Assembly in June 2017

(Resolution CSP29.R13). The scale of assessments to be applied by PAHO for 2019 (the second year of the 2018-2019 biennium) depends on the progress and outcome of the discussion by the OAS General Assembly regarding its own scale of assessments for the 2019 period and beyond.

- 5. On 19 June 2018, the Permanent Council of the OAS proposed a scale of quota assessments for the years 2019-2023. The proposal consists of maintaining the same percentage calculation of quotas applied for 2018 during 2019 and 2020, and modifying the percentage calculation from 2021 onward.
- 6. The OAS General Assembly will consider the proposed scale of 2019-2023 at its next special session in October 2018.

Proposed Approach

- 7. Given that the OAS proposed scale of quota assessments for 2019-2023 has not yet been adopted, the Bureau proposes to maintain PAHO's 2018 scale of assessments for the 2019 financial period (Annex A).¹
- 8. In the interest of clarity, and to provide Member States with an overview of the biennial implications for the proposed 2019 scale, Annex B provides a biennial comparison of the assessment scales for 2016-2017 and 2018-2019.
- 9. The actual amounts of assessed contributions to be paid by PAHO Member States, Participating States and Associate Members based on the proposed 2019 scale of assessments is attached as Annex C.
- 10. Upon approval of the OAS scale of quota assessments for 2019-2023, the Bureau will submit a new PAHO Scale of Assessments for 2020-2021 for Member States' consideration at the 57th Directing Council in 2019.

Action by the Directing Council

11. The Directing Council is invited to take note of this report and adopt a Scale of Assessed Contributions for 2019 together with the Assessed Contributions for Member States, Participating States and Associate Members, as contained in the proposed resolution (Annex D).

PROPOSED RESOLUTION

SCALE OF ASSESSMENTS AND ASSESSED CONTRIBUTIONS OF THE MEMBER STATES, PARTICIPATING STATES, AND ASSOCIATE MEMBERS OF THE PAN AMERICAN HEALTH ORGANIZATION FOR 2019

THE 56th DIRECTING COUNCIL,

- (PP1) Noting that the 29th Pan American Sanitary Conference, throught Resolution CSP29.R6, approved the Pan American Health Organization's (PAHO) Program and Budget 2018-2019 (*Official Document 354*), and that approximately one-third of the PAHO Program and Budget 2018-2019, will be financed from assessed contributions from PAHO Member States, Participating States, and Associate Members;
- (PP2) Considering that Article 60 of the Pan American Sanitary Code and Article 24 (a) of the PAHO Constitution provide that the scale of assessed contributions to be applied to PAHO's Member States, Participating States and Associate Members be determined on the basis of the assessment scale adopted by the Organization of American States (OAS);
- (PP3) Recalling that the 29th Pan American Sanitary Conference approved PAHO's scale of assessed contributions for the 2018 financial period (Resolution CSP29.R13), as adapted from the 2018 OAS transitional scale, and established the assessed contributions for PAHO Member States, Participating States and Associate Members for 2018 (Resolution CSP29.R14);
- (PP4) Noting that Resolution CSP29.R13 of the 29th Pan American Sanitary Conference also requested that the Pan American Sanitary Bureau submit for consideration of PAHO's Governing Bodies a revised scale of assessment for fiscal year 2019 on the basis of the 2019 OAS scale of assessments;

- (PP5) Considering that the OAS General Assembly has not yet adopted its scale of quota assessments for the period 2019 onwards; and
- (PP6) Having considered the report contained in Document CD56/7, Scale of Assessments and Assessed Contributions of the Member States, Participating States, and Associate Members of the Pan American Health Organization for 2019,

RESOLVES:

- (OP)1. To establish the scale of assessed contributions of the Member States, Participating States, and Associate Members of PAHO for the year 2019 based on the 2018 PAHO scale of assessments, as shown in Table 1 below.
- (OP)2. To approve the assessed contributions for Member States, Participating States, and Associate Members of PAHO for the year 2019, as shown in Table 2 below.
- (OP)3. To call upon the Pan American Sanitary Bureau to revise the scale of assessment and assessed contributions of Member States, Participating States and Associate Members of the Pan American Health Organization for the financial period 2020 and beyond, when the Organization of American States adopts a new scale of assessments for the same period.
