### MONITORING OF THE RESOLUTIONS AND MANDATES OF THE PAN AMERICAN HEALTH ORGANIZATION

#### **Introduction**

1. This report responds to Resolution CD55.R11 (1), which mandated that the Pan American Sanitary Bureau (PASB, or the Bureau) present an analysis on the status and implementation of resolutions and documents approved by the Governing Bodies of the Pan American Health Organization (PAHO) to Member States at least every three years. The report aims to enable Member States and other stakeholders to monitor progress on international commitments to public health.
2. A first report on the assessment of the resolutions adopted by PAHO was presented to the Governing Bodies at the 55th Directing Council in 2016 (2). This first report covered a period of 17 years (1999-2015) and defined a methodology for the analysis of the mandates.
3. Applying the same methodology, the present information document provides an updated analysis on the status and implementation of the PAHO resolutions. The report encompasses the resolutions that were Active and Conditional Active for the period 1999-2015 and incorporates the resolutions adopted by PAHO over the period 2016-2018.

#### **Analysis of PAHO Resolutions (1999-2018)**

4. For the purpose of this analysis, an interprogrammatic working group, comprised of representatives from the offices of the Deputy Director, Assistant Director, and Director of Administration, was established. For background, the working group drew on the Analysis of the Mandates of the Pan American Health Organization (Document CD55/18, Rev. 1) and on the experience of the members of the prior working group.

## Methodology

5. To ensure consistency in the analysis, the same methodology developed for the 2016 report was used to review the status of the resolutions adopted by the Directing Council and the Pan American Sanitary Conference. The methodology consisted of the following steps:

- a) Determine the period of analysis of resolutions (1999-2018).
- b) Use the previously established criteria for determining whether a resolution can be classified as Active, Conditional Active, or Sunset (Table 1).

**Table 1. Criteria for Determining the Classification of Resolutions**

<sup>1</sup> When the resolution or the document endorsed or approved by the resolution clearly stipulates the lifespan, that information should be included in the analytical section of the resolution.

<sup>2</sup> The working group shall review all operative paragraphs in each resolution and determine whether each commitment made by the Member States and Bureau has been met, whether there is no information at the time of the study, or whether the commitment remains in force.

<sup>3</sup> For the purposes of this study, a resolution is considered to be relevant if it meets one or more of the following criteria: *a*) the subject is included in the PAHO Strategic Plan 2014-2019 (Amended); *b*) the preamble section of the resolution is still valid; *c*) it is explicitly related to the global mandates of an international organization of importance to PAHO; or *d*) it calls for PAHO technical cooperation at the regional level.

- c) Base the review on the categories and program areas of the PAHO Strategic Plan 2014-2019 (Amended) (3) (see Annex A).
- d) Analyze the resolutions in the updated document of mandates according to the following aspects:
  - i. Lifespan: whether the resolution or document endorsed by the resolution explicitly includes time-marked information.
  - ii. Replacement: whether the resolution was superseded by another more recent one, in which case the one that superseded it shall be noted.
  - iii. Compliance with mandates: whether each commitment established for the Bureau and the Member States has been met or whether the mandate remains in force. If information was unavailable at the time of the study, this shall be stated in the report.
  - iv. Progress reports: whether the resolution or the document endorsed by the resolution stipulates the periodicity with which progress reports must be submitted. If so, it shall be determined whether the reports were submitted as stipulated.
- e) Issue a recommendation for each resolution pursuant to its findings.
- f) Submit a report on the status of resolutions to the 57th Directing Council of PAHO, 71st Session of the Regional Committee of WHO for the Americas in September 2019.


6. The resolutions were classified according to the categories of the PAHO Strategic Plan 2014-2019 (Amended) and were reviewed from the oldest to the newest, following the same format used in 2016. In the case of resolutions pertaining to cross-cutting categories, the working group placed them in the category corresponding to the largest number of mandates in the resolution.

7. The resolutions that were determined to be Sunset by the 55th Directing Council were removed from the document and those resolutions adopted in the last three cycles of Governing Body meetings were included. The document also includes updated information related to progress, midterm, and final reports presented during 2016-2018.

### ***Results***

8. Between 1999-2018, 325 resolutions were adopted by the Governing Bodies, 162 of which were Sunset by the 55th Directing Council and therefore not included in the report. The remaining 163 resolutions were Active or Conditional Active. Of the 163 resolutions, Category 6, Leadership, Governance, and Enabling Functions, had the largest number of resolutions (56, or 34.3%), followed by Category 4, Health Systems (27, or 16.6%), and Category 3, Determinants of Health and Promoting Health throughout the Life Course (26, or 15.9%). Category 1, Communicable Diseases, and Category 2,

Noncommunicable Diseases and Risk Factors, each had 23 resolutions (14.1%) and Category 5, Health Emergencies, the smallest number (8, or 5.0%) (see figure 1).



9. According to the defined methodology, the working group proposes to maintain 92 resolutions Active (56.4%), 13 Conditional Active (8.0%), and Sunset 58 (35.6%) (see table 2). A summary of the resolutions by category, including their number, title, year of adoption and finalization, type of document, reporting requirement, and progress reports presented to the Governing Bodies is available in Annex B. For each resolution, a recommendation on the status is presented for consideration by the Governing Bodies.

10. The 13 resolutions that the working group rated as Conditional Active are expected to be superseded or finalized by 2021.

## **Conclusions**

### ***Limitations***

11. The working group found some limitations in determining compliance with the mandates entrusted to the Member States and the Bureau, especially with the oldest resolutions. Until recently, resolutions and documents did not include specification of the type of document (policy, strategy, plan of action, or other). For these cases, the working group used the classification currently followed by the PAHO Governing Bodies whenever possible. Another weakness observed in the older resolutions and documents was the lack of information on reporting requirements and financial implications.

### ***Recommendations***

12. Although there has been a notable improvement in the harmonization of documents and resolutions in recent years, there is still a need to strengthen the focus of sustainable initiatives and mandates on fulfillment of the Strategic Plan and the Sustainable Health Agenda for the Americas 2018-2030. To ensure transparency and accountability of future resolutions, they will need to continue to include reporting requirements, clear mandates, capacity for implementation, and financial implications.

13. To continue its efforts to monitor the resolutions of the Governing Bodies, PASB will need to align future reports on the status of resolutions with the PAHO Strategic Plan 2020-2025, which will be presented to the Governing Bodies in September 2019.

## **Action by the Executive Committee**

14. The Executive Committee is invited to take note of this report and provide any recommendations it deems pertinent.
