

# Pan American Health Organization Ethics Review Committee

**2021 Annual Report** 

**Abridged version, March 2022** 







#### Overview

In 2021, PAHOERC continued to meet the challenges of the COVID-19 pandemic, which included a surge in research efforts –primarily COVID-19 studies– and increased demand for research ethics guidance and support. PAHOERC continued to operate under its emergency operating procedures to meet the increased needs for timely ethics review, prompting more frequent meetings and the sustained commitment of PAHOERC members and observers.

PAHOERC received 99 unique proposal submissions for countries and/or territories in the Region in 2021, 27 of which were related to COVID-19. Of the proposals requiring full PAHOERC review, 28 were reviewed by a quorum of members during 11 regular meetings. Seven auxiliary meetings were also held to accommodate the rapid review of COVID-19 protocols. Twenty-six proposals for research with human subjects were ultimately approved for implementation in the LAC region in 2021, 7 of which were related to COVID-19.

As the COVID-19 pandemic continues to stress the importance of research, ensuring that research is conducted in adherence to the highest ethical standards is more urgent than ever. The Region witnessed a mainstreaming of research efforts in 2021, such as the widespread use of digital surveys, at the same time that prominent cases of unethical research on COVID-19, including involving fraud and misconduct, were revealed and received ample coverage in the media<sup>1</sup>. These events hamper trust in research as well as in the public health interventions that result from research, such as COVID-19 vaccines. It is therefore imperative to escalate efforts to ensure the ethical conduct of research in the Organization and across the Region.



# 1. Summary of activities

# Ensuring that human subjects research in which PAHO is involved meets ethical standards

In 2021, PAHOERC received 104 submissions through its online portal, 99 of which were unique submissions aiming to conduct research in multiple countries (each country is accounted for in the figure below); most proposals targeting the LAC Region as a whole involved online surveys or regional databases.



Some proposal submissions represent research that will take place in more than one country or subregion; all countries represented here.

#### Of these 99 submissions:

- **61** were granted an exemption from full PAHOERC review, in accordance with the criteria established by its SOPs.
- 34 proposals were deemed research with human subjects thus requiring full review by the committee or further action by the Secretariat (similar to previous years).
- 28 proposals were reviewed by a quorum of members during 18 meetings in 2021 (some proposals are still pending review as of 2022).
- 26 proposals were ultimately approved for implementation in countries of the LAC Region in 2021 (including three proposals submitted in 2020).
- 7 of the 26 proposals approved were COVID-19 studies.

Proposals submitted in 2021 reflect the context of the pandemic: a surge (28 submissions) of COVID-19-related projects and fewer proposals on regular annual cluster projects. Other topics included a high volume of proposals focused on migrant needs related to reproductive health and infectious diseases, (managed by FPL/CLAP); proposals on the topic of Operational Research in the Context of Advancing Towards TB Elimination in the Americas (funded by the TDR-Structured Operational Research and Training Initiative

(SORT IT)); alcohol/tobacco use, HIV/AIDS prevention, and online surveys focusing on mental health. The total number of proposals received represents a slight increase from 2020 and is consistent with the average submitted during the previous five years.

# PAHOERC Member and Observer Contributions

The remarkable commitment of PAHOERC members and observers to their duties ensuring all research in which the Organization is involved is ethical was further tested during the second year of the COVID-19 pandemic. A significant number of COVID-19-related research proposals created a greater workload for members by prompting 7 additional PAHOERC meetings in 2021, and many proposals required more attention due to newly emergent evidence related to SARS-CoV-2. Member and observer contributions included:

- Reviewing materials and evidence on tight deadlines, time spent in virtual meetings or preparing written comments, responding to follow-up requests from the Secretariat.
- Additional meetings with research teams and detailed reviews of protocol components via email on areas of member's expertise.
- Participating in Organization-wide refresher trainings for staff on the PAHOERC requirement.

A new member was added in 2021 to help accommodate an increased volume of proposals toward the end of 2021. The pandemic has opened the possibility of including members that are not based in Washington D.C., which had not been successfully accomplished previously. The Committee continues to seek a new member from the Caribbean to enhance geographical representation among members.

# 2. Building capacity in research ethics

Capacity-building requests at PAHO and through the Region — and overall requests for support — continue to be very high because many teams that usually do not conduct research are pursuing COVID-19 research projects.

#### **Trainings**

Internal capacity-building activities in 2021 included a combination of individual consultations via phone and email; trainings targeted to certain grant project teams; and general trainings for specific departments and to the Organization more generally, including:

- Organization-wide refresher training sessions (in English and Spanish) on PAHO's ethics review requirement with a focus on the context of the pandemic (October);
- Training sessions on research ethics and ethics review processes for awardees of the CDE/TDR Small Grants Training Program (SORT IT) (July) and CLAP's EVISIP 21 research grants (September); presentation on PAHO's ethics review requirements for PAHO's Risk communication and community engagement (RCCE) regional group (October) and Colombia's teams conducting COVID-19 research projects funded by the Korean International Cooperation Agency (KOICA) through PAHO.

Capacity-building efforts in the LAC Region in 2021 mainly focused on the challenges posed by COVID-19 research, and on the topics addressed in <u>PAHO's COVID-19 ethics guidance documents.</u> Numerous training sessions in both languages on these topics were delivered at the request of national authorities or key institutions of many countries in the Region (including Argentina, Bolivia, Brazil, Chile, Colombia, Costa Rica, Guatemala, Mexico, Panama, and Peru). The health authorities of Bolivia and Costa Rica further requested training series for their research ethics committees involving monthly sessions, supplemented by an additional four-session weekly series focused on training in procedural issues for Bolivia.

#### Communications materials

Several communications materials were developed in 2021 to disseminate quality information in research ethics (in English, Spanish, Portuguese, and French):

- Two videos on the work of research ethics committees:
  - o When does health research need ethics review? (also in Spanish/Portuguese/French)
  - What do research ethics committees review? (also in <u>Spanish/Portuguese/French</u>) (The videos were collectively viewed more than 16,600 times by the end of 2021); infographics were produced with the same content (English/Spanish).
- Three <u>animated videos</u>, <u>infographics</u>, <u>and social media cards were</u> produced highlighting the role of research in the COVID-19 response and the importance of conducting ethical research.
- <u>Nine additional videos</u> (in English/Spanish) on ethics and clinical research that were originally developed by Argentina's Proyecto ACERCA were adapted and revised by PAHO.

### Advancing ethical standards in research

In conjunction with the Regional Program on Bioethics, ethical standards in research were advanced in 2021 through a systemic approach using indicators, which entails providing support to countries to assess

their national research ethics systems using the indicators and developing national research ethics policies (e.g. Guatemala), laws (e.g. El Salvador) or specific interventions (e.g. Costa Rica) to meet the indicators that are not currently achieved. Activities in support of this approach in 2021 included:

- Three bilingual regional dialogues (attended by almost 400 participants and viewed more than 1,100 times after) to present the indicators and discuss their use by national authorities, and share regional assessments using the indicators (Following PAHO's 2021 publication of <u>Indicators for</u> <u>Strengthening National Research Ethics Systems</u>).
- Submission for publication (to *The Lancet Global Health*) of the regional assessment that was initiated with NIH's support before the pandemic.
- Publication of a WHO-funded external regional assessment on the indicator pertaining to emergencies.

Other activities carried out in 2021 in the Region to advance ethical standards in research included:

- Implementation of <u>PAHO's COVID-19</u> ethics guidance documents, which entailed close coordination with the Incident Management System Team (IMST) and numerous presentations of these documents in national, regional, and global meetings.
- A regional bilingual webinar to present and discuss PAHO's <u>Guidance for ethics oversight of COVID-19 research in response to emerging evidence</u> involving discussants from national authorities took place in March (attended by ~ 500 participants and viewed almost 900 times).
- Promotion of ethical standards for research with children (a concern in the Region due to the initiation of COVID-19 vaccine trials with children):
  - Development of related content for <u>PAHO's website</u> (also published by media in Trinidad and Tobago), infographics, social media cards.
  - Facebook live sessions with experts in <u>English</u> and <u>Spanish</u> (with more than 4,000 attendees and viewers), and coordinated efforts with FLP.
- Ethical standards advanced in coordination with WHO for COVID-19 human challenge trials, human genome editing—with regional sessions to advance community engagement and disseminate WHO's new governance framework—, and gene drive research—in collaboration with NIH Foundation and CDE, and building on WHO's Guidance on ethics and vector-borne diseases.
- Promotion and support toward the implementation of the PAHO-developed ProEthos system:
  - o Presentations to committees/institutions in Bolivia, Costa Rica and Guatemala, in coordination with their national health authorities; to a network of research ethics

committees in Ethiopia and to the WHO's Eastern Mediterranean Regional Office; WHO-ERC's Ad-hoc COVID-19 committee.

- Support to the United States Office of Human Research Protections (OHRP) 2021 revision of the International Compilation of Human Research Standards, which features 28 countries of the Region.
- A General Information Bulletin (<u>GIB-HQ-CO-Centers-21-1333</u>) was issued in October in collaboration with PAHO's Ethics Office to advance the ethical conduct of research conducted by PAHO personnel or with PAHO's financial or technical involvement (with supplementary informative sessions in English and Spanish).

# Maintaining PAHOERC's institutional memory

2021 was PAHOERC's second full year utilizing ProEthos as the sole platform for process facilitation and institutional recordkeeping, which has eliminated subscription and maintenance costs incurred by the Organization for a digital platform. In 2021 the Secretariat conducted additional testing and worked with BIREME on adjustments to optimize the platform, which have included substantive modifications to adhere to WHO's new cybersecurity standards.

An abridged version of PAHOERC 2020 annual report was developed at the request of the Deputy Director's Office for dissemination with broader audiences. PAHOERC continues to make updated lists of COVID-19 submissions available at <a href="www.paho.org/pahoerc">www.paho.org/pahoerc</a>, whose traffic increased in the last year by 1,827%: from 155 viewers in 2020 to 2,939 in 2021.

#### 3. Recommendations

- 1. Fund the STP position to support PAHOERC in the 2022-23 biennium to ensure PAHOERC can sustainably fulfill its corporate function.
- 2. Continue in-house training on research ethics and the Organization's ethics review requirement, focusing on challenges posed by the COVID-19 pandemic as appropriate.
- 3. Continue supporting IMST, as needed, and operating under the emergency procedures. Conduct an assessment, based on an analysis of the experience in the 2020-2021 biennium, of the need to adjust the emergency procedures described in the PAHOERC SOPs to improve the Committee's response to emergency scenarios.
- 4. Adapt WHO's Code of Conduct for responsible Research and WHO's Policy on Misconduct in Research for inclusion in PAHO's E-manual to advance adherence to ethical standards in research among PAHO personnel.
- 5. Continue supporting the implementation of ProEthos.
- 6. Disseminate PAHOERC's 2021 Annual Report and abridged version outside the Organization.
