INSTRUCTIONS

This annex provides a proposal for the content of the EPI situation analysis report.

This document can be compiled alongside the desk review. If data is not available through the desk review, the gaps should be highlighted in this report so that this data can be collected through sub-national and local level visits.

All required information refers to the last year with complete data, except when a different period is specified (eg, for vaccination coverage data, 5 years is requested).

If one or more components of the template are not applicable to the country, this fact can be noted in the report without further elaboration.

It is important that the sources of information for the reported data and descriptions are included. All supporting documentation for the data and information presented in this report must be available to the members of the evaluation team in digital media. The supporting documents must be organized according to the components of the report, respecting their numbering.

The situation analysis report comprises seven sections. These have been laid out below:

Section 1: Executive summary (1 page maximum)

Section 2: Details about the EPI performance monitoring self-assessment (2 pages maximum + tables)

 Dates of the national Immunization Program Performance Monitoring implementation (from the hiring of the PAHO consultant part of the National Coordination Team).

- Members of the working group at the national and regional level.
- Key informants and sites visited at the subnational and local level.
- Objectives of the mission to monitor the performance of the national Expanded Program on Immunization.
