






Incidence (HIV+TB in orange), notifications (black) (rates per 100 000 population)



Prevalence (rate per 100 000 population)




Mortality excluding HIV (rate per 100 000 population)






Role CAREC TB surveillance

- Support to yearly reporting to WHO
(electronic file for case-based TB monitoring available)
- Assistance to national TB program and TB outbreaks
- TB Xpert system, not to replace TB culture / smear
- Training / quality control TB smear
