COVID-19 SITUATION UPDATE #14

18 July 2020

I. HIGHLIGHTS

Trinidad and Tobago

At the Ministry of Health Virtual Media Conference, held on Wednesday, 15 July 2020, the Minister of Health, Hon. Terrence Devalsingh, announced that Trinidad & Tobago will be allowed equitable access to COVID-19 vaccinations when they become available.

On Saturday, 18 July 2020, at the Virtual Media Conference, the Minister of Health announced that the public health regulations are in the process of being amended and effective Monday 20 July 2020, bars will be allowed to open until 10:00pm. At the same time, he also addressed the breakdown of public gathering protocols that occurred on Nomination Day and asked Campaign Managers and Candidates of both Political Parties to ensure that it does not happen again. He went on to speak about the 3 nationals that tested positive for COVID-19 on the previous day and confirmed that they were imported cases from Grenada. The Chief Medical Officer, Dr. Roshan Parasram, in his clinical update indicated that there has been one additional positive case of COVID-19 from a recently repatriated group of nationals.

Dutch Territories

In Aruba, the number of cases increased to 113. The new cases are visitors who were tested upon arrival at the airport. These persons have been put in quarantine. Aruba requires persons traveling to complete an embarkation/ disembarkation card, upload a PCR test result taken 72 hours before departure to Aruba and purchase visitor insurance. Residents of the United States and other countries with whom Aruba's borders are open will have the alternative option of taking a PCR test immediately upon arrival in Aruba, which is mandatory if a negative test was not uploaded within the required timeframe prior to arrival. The test is followed by a mandatory guarantine at the visitor's booked accommodation until test results are finalized. Mandatory quarantine means that the person must stay in their room until the test results are known and persons are to avoid contact with other guests and staff at the accommodation. The cost of this test is US\$75 per person and needs to be prepaid as part of the online embarkation/disembarkation process. Those states that must upload prior to travel are Alabama, Arizona, Arkansas, California, Colorado, Florida, Georgia, Idaho, Iowa, Kansas, Louisiana, Mississippi, Nevada, North Carolina, Ohio, Oklahoma, Oregon, South Carolina, South Dakota, Tennessee, Texas, Utah, Wisconsin, and Wyoming.

In **Curação** the COVID-19 cases have increased to 28 since the borders were opened. The first of the 3 cases was a US Soldier at the US Base in Curação. The are related to persons who entered Curação from the US via Aruba. Both are in quarantine. The borders continue to remain closed to the United States but open to the Netherlands.

In **Sint Maarten** of the 75 persons tested at the airport on their return to St. Maarten as part of the repatriation flight from Fort Lauderdale, Florida, one person tested positive for COVID-19 and one person tested inconclusive which is being repeated. This brings the total number of cases to 79. Sint Maarten's borders are still officially closed to US visitors.

In **Bonaire, Saba, Sint Eustatius** the number of cases in Bonaire has increased to 5. With Aruba opening their borders to the US, Bonaire issued a new emergency ordinance that decrees that anyone who was in a high risk country within the previous two weeks is barred from entering Bonaire.

Because of the new case of COVID-19 announced in St. Maarten on Wednesday, St. Eustatius has increased the level of COVID-19 risk in St. Maarten from low to medium. As a result, anyone arriving from St. Maarten will have to go into home-based quarantine for fourteen days. Business, tourist and family visits are only allowed from low-risk countries. Saba still has Sint Maarten listed as low risk.

3rd Tranche of COVIID-19 support from Holland— Negotiations are ongoing.

III. RESPONSE

A. Key Trinidad and Tobago/Repatriation Response to COVID-19, 18 July 2020

At the Media Conference held on Monday, 13 July 2020, the following were discussed:

- Prime Minister Dr. the Hon. Keith Rowley said that approximately 10,000 persons have requested exemptions to return to Trinidad and Tobago. He went on to state that as of 11 July 2020 the Ministry of National Security has granted approximately 4,515 exemptions since the borders were closed on 23 March 2020.
- Nationals have been repatriated from Guyana, Venezuela, Suriname, Barbados, Cruise ships, Cuba, St Maarten, UWI and other students from Jamaica and Barbados. There have also been smaller flights permitted with persons with medical issues.
- The Government has worked with the energy sector and oil and gas companies to permit entries of
 workers to keep the industry running uninterrupted. These workers have entered and left via private
 charter flights and the use of marine service vessels and rigs.
- Exemptions were granted to students in India, to persons in the UK, Europe and the Middle East. Plans are currently in place for repatriation of nationals from Grenada and Canada, using Caribbean Airlines.
- The border entries are being very carefully managed, and the numbers of exemptions being granted are based on the capacity of the public health care system to manage state quarantine and state supervised quarantine.
- The Government has a number of state quarantine facilities, including: UWI Debe Campus, Home of Football in Couva, Tacarigua Racquet Center, Balandra and NAPA. These are fully manned by the state using both Ministry of Health and Ministry of National Security.
- The Government also has state supervised quarantine facilities where returning nationals pay the
 costs for hotel accommodation under state supervised quarantine. This is being done at Chancellor
 Hotel and Cascadia Hotel, again, under the supervision of the Ministry of Health and the Ministry of
 National Security. In an effort to expand the number of returning nationals, the State has added
 another hotel in Piarco as a state supervised quarantine facility.
- The Ministry of National Security in granting exemptions to the initial numbers of nationals in Canada, the UK, Europe and the Middle East has asked persons whether they would wish to pay for the cost of state supervised quarantine or whether they require state quarantine. Depending on the responses, the number of exemptions granted may marginally increase.
- Each application is being dealt with on a case by case basis.

- Lack of continuous supply of RNA extraction kits which also remains a principal challenge at the regional level
- Nasopharyngeal swabs are difficult to obtain as there are overall production and shipping challenges
- Aruba, Curação and Sint Maarten continue to negotiate with the Kingdom Council of Minsters
