PAHO Director calls for equitable access as new vaccines cleared for delivery

Washington, D.C., February 17, 2021 (PAHO) With COVAX delivery of new vaccines expected soon in the Americas, Pan American Health Organization (PAHO) Director Carissa F. Etienne called for overcoming barriers to ensure "fair and equitable access."

"As we start delivering COVAX vaccines, and as we prepare for the steep scale-up ahead, we must be guided by our vision of fair and equitable access at every step of the way. We must overcome the structural barriers that prevent the most vulnerable from being immunized and we can only do that by working together."

On Monday, WHO issued Emergency Use Listing (EUL) for two versions of the Oxford AstraZeneca vaccines, one from AstraZeneca-SKBio of Korea and the other from the Serum Institute of India.

The approval cleared the way for distribution to the

37 countries in the Americas that are participating in COVAX. The countries will receive confirmation from COVAX regarding the timeline and number of doses within days or weeks, Dr. Etienne said.

"Over the coming days, countries will face important tasks as they prepare for the arrival of vaccine doses," she said. "Any small delays could set vaccinations back weeks, so countries must make vaccine readiness their number one priority."

She said there are two vital areas of preparation – the legal and regulatory frameworks required to deliver the vaccines and hiring and training staff needed to conduct mass immunization. "We urge all countries to act quickly, be ready, and save lives," she said.

For months PAHO has worked to help countries prepare, negotiating directly with manufacturers to streamline agreements and reduce the burden on national governments. Read more...

PAHO's Response



Diplomatic Community receives 4th update on COVID-19 pandemic and vaccine rollout in Barbados and the Eastern Caribbean Countries

Bridgetown, Barbados, February 17, 2021 (PAHO) – The PAHO/WHO Office for Barbados and the Eastern Caribbean Countries hosted a fourth meeting with Heads of Diplomatic Missions resident in Barbados, Heads of International and Regional Organizations, and the Honorary Consular Corps accredited to Barbados, to provide an update on covid-19 situation and progress.

Forty-one (41) participants in attendance were updated on the current situation of the pcovid-19 outbreak, SARS-CoV-2 virus variant and implication in the pandemic, the rollout of covid-19 vaccines, and the support and technical cooperation provided to member states by PAHO/WHO Office for Barbados and the Eastern Caribbean Countries during 2020.

Mr Didier Trebucq, UN Resident Coordinator, Barbados and OEC, in his remarks thanked PAHO for organizing the meeting and highlighted the importance of the session given that the region, since the end of the year, is facing a new wave of COVID-19 cases, resulting in more stringent public measures," he said.

Mr Trebucq expressed concern about the socio-economic impact of countries in the region given the new wave of cases. He, however, noted that the vaccine rollout as a strong response to the crisis, informing that PAHO and the UN system is mobilized to make the vaccination campaign a success.

Dr Yitades Gebre, PAHO/WHO Representative for Barbados and the Eastern Caribbean Countries after welcoming the participants, provided the global, regional and Caribbean specific overview of the pandemic focusing on the Caribbean islands that experienced a surge in covid-19 cases since the end of 2020.

Changes in the virus genomic sequence or mutations was explained by Dr Gebre and SARS-COV-2 variants of concern in the region of the Americas outlined.

The PAHO incident management team provided a comprehensive presentation including the progress on the execution of the COVID-19 Strategic Preparedness and Response Plan (SPRP), under 9 thematic pillars. PAHO also presented the mobilization and execution of US\$ 9 million in response to the outbreak in the Eastern Caribbean countries.

The status of the COVID-19 vaccine rollout globally and in Barbados and the Eastern Caribbean Countries was highlighted. Seventy-three (73) days after the application of the first dose of the vaccine, 183.63 million doses of 8 different types of vaccines in three platforms are in use by countries. Barbados few other Eastern Caribbean countries and territories were able to commence vaccination of frontline workers.

Participants were also informed on PAHO's support to countries during the vaccine rollout.

The dignitaries appreciated the update provided by the team of PAHO multi-country office. The discussion on monitoring the progress and status of covid-19 vaccine deployment and rollout attracted great interest and was discussed during the questions and answers session. The COVID-19 implications on non-communicable diseases and mental health were also addressed.

In closing Dr Gebre thanked dignitaries for their participation in the meeting, reassuring of PAHO's continued support and guidance. He further concluded that the start of vaccine delivery is hopeful step in the fight against the pandemic.
