COVID-19 Situation Update - 139

This situation update is on the Novel Coronavirus (COVID-19) reported cases, deaths and related vaccination status, Globally, Regionally, for Barbados and the Eastern Caribbean Countries, French Territories, and the United Kingdom Overseas Territories.



PAHO calls for strengthened government action to protect populations from the COVID-19 pandemic's health and social impacts

Washington, D.C. September 10, 2021 (PAHO) - On the eve of Wellness Week 2021, the Pan American Health Organization (PAHO) is calling on governments to strengthen social support mechanisms to foster health equity and help people cope with the impacts of the COVID-19 pandemic and recovery.

"I want to strongly urge all governments and individuals to make more concerted and determined efforts to build equitable communities so that together we can dismantle those barriers that prevent all people from having the same opportunities for health, wellness, and well-being," PAHO Director Carissa F. Etienne said in a video message marking Wellness Week celebrated September 11-17.

"However, one lesson that this pandemic has also taught us is that it is not enough for communities to come together," Dr. Etienne continued. "Individuals facing difficulties should not have to rely on the kindness and good will of their neighbors just to survive. Health and well-being for everyone can only be achieved when governments provide a safety net..."

This year's Wellness Week recognizes the pandemic-induced deterioration of conditions for people in situations of vulnerability in Latin America and the Caribbean, Poverty rose to levels not seen in 12 years in 2020, and extreme poverty reached levels not seen in 20 years, according to the Economic Commission for Latin America and the Caribbean (ECLAC). The decline has worsened the already severe divide between rich and poor in the region.

In her video message, Dr. Etienne addressed these populations, emphasizing that "implementing

meaningful social support measures to protect people such as migrants, those living in poverty, workers in the informal sector, the majority of whom are women, or in precarious working conditions, or residences of crowded housing, and those living in other conditions of vulnerability is the only way to move toward greater equity in health and well-being."

COVID-19 highlights:

ANTIGUA & BARBUDA	The dashboard dated 12th September 2021, reported 131 new COVID-19 cases. In a 13th August statement from the Sir Lester Bird Medical Centre, 4 deaths were reported, all females ages 25, 78, 80 and 97.
BARBADOS	78 new cases were reported in a 12th September 2021 dashboard. Of these cases 22 are under the age of 18 and 56 are 18 years and older. 35.6 percent of the population is now fully vaccinated. In a September 9, 2021 address to the nation, Prime Minister Mia Amor Mottley announced that to assist with the vaccination campaign, private doctors will also be allowed to administer COVID-19 vaccines. The government will pay the doctors for this service so that citizens would not be charged. Barbados also rolled out mobile community vaccination stations, to make vaccines more accessible.
GRENADA	In a dashboard dated September 13, 2021, 260 new COVID-19 cases were reported and 2,063 active cases.
ST. KITTS AND NEVIS	12 new COVID-19 cases were reported in a September 12, 2021 dashboard and 620 active cases, there was also 1 death.
SAINT LUCIA	10 new COVID-19 cases were reported on September 13, 2021, with 2,402 active cases. COVID-19 protocols in Saint Lucia were extended for another seven days commencing Wednesday September 15, 2021 to Tuesday September 21, 2021. The protocols include a curfew 7pm to 4am Monday to Friday, with a 24 hour curfew on Sunday.
ST. VINCENT & THE GRENADINES	In a September 12, 2021 press release, one local Gamma variant case and 41 new COVID-19 cases were reported. St. Vincent and the Grenadines confirmed the presence of the Delta, Mu and Gamma variants in the community, there is a strict enforcement and compliance with all protocols and recommendations.


