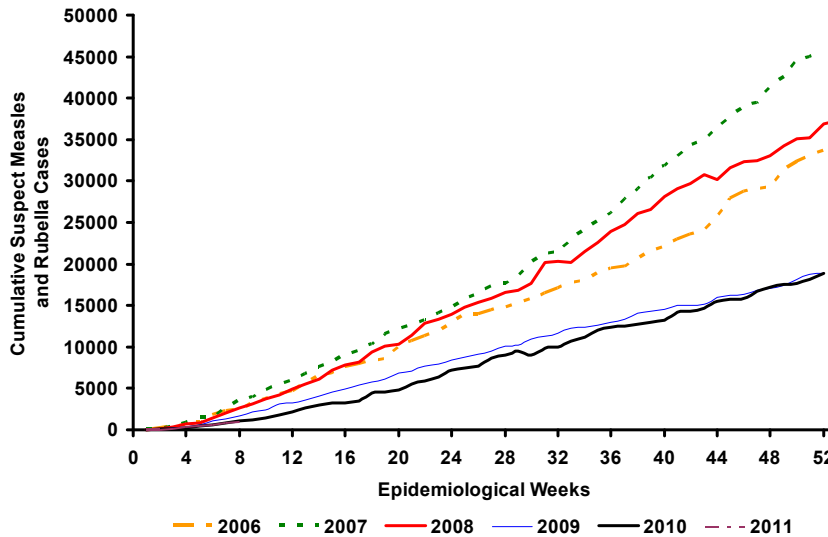




### Cumulative Suspect Measles and Rubella Cases by Epidemiological Week, The Americas, 2006–2011\*
