

INTRODUCTION

This publication follows two previous reports produced by the Pan American Health Organization (PAHO), in 2005 and 2006, with the purpose of providing data on the progress of the plan to strengthen blood banks in the Region of the Americas that was approved by PAHO's Directing Council in October 1999¹. The previous publications, Transfusion Medicine in the Caribbean and Latin American countries, 2000-2003², and National Blood Systems in the Caribbean and Latin American Countries: Basic Indicators of their Status in 2004³, provided a summary of the data on organization of the blood national blood systems and indicators of blood availability and safety received each year from the majority of the 41 countries/territories.

The national blood systems of the Caribbean and Latin American countries made important progress during the period 2000-2004⁴. Nevertheless, the Region-wide expected results –universal screening of blood for infectious markers, 50% voluntary blood donation, and participation of all blood banks in quality programs - were not achieved. The potential issues that may have hindered progress as planned in 1999 were analyzed by PAHO and presented to the Directing Council in 2005. The existence of fractured blood services in most of the countries was identified as the main limiting factor for achieving sufficiency and adequate quality and safety of blood used for transfusion⁵. As a consequence, the Directing Council of PAHO approved a plan of action for 2006-2010 which emphasizes the planning and management of the national blood network systems as a means to achieve sufficiency, opportunity and acceptable quality of the blood for transfusions, and the safety of the transfusions themselves⁵ (Annex). The present report provides the baseline data for monitoring progress of the countries in attaining the results expected by the end of 2010.
