EU-LAC meeting, Italy, April 11-12, 2013

EU-LAC Health's second "Scenario Building Workshop" was held in Rome. Luis Gabriel Cuervo participated in the meeting and chaired sessions as member of the Advisory Board. His participation was coordinated from the outset with the External Relations Area and other relevant PAHO Area Managers. Throughout the event, European and Latin American health sector experts met with project partners in order to discuss potential scientific areas and possible funding mechanisms for health research collaboration between the European Union and Latin America and the Caribbean.



Brock-McMaster Global Health Forum, Canada, January 26, 2013



Dr. Vic Neufeld, national coordinator of the Canadian Coalition for Global Health Research (CCGHR), and Professor Ana Sanchez invited Luis Gabriel Cuervo to be a keynote speaker at the Global Health Forum co-organized by Brock and McMaster universities in alliance with CCGHR, which has collaborated with EVIPNet Americas in the past. "Discovering Global Health in your future" showcased PAHO's <u>Art for Research</u> project, showing how, in the context of health, art can be a medium to convey messages of development, equity and success. Luis Gabriel also discussed knowledge translation and presented EVIPNet as one of the strategies developed at PAHO in this regard.

UWI named Caribbean Branch of the US Cochrane Center (CBUSCC) in Jamaica

The University of the West Indies, Mona campus, through its Tropical Metabolism Research Institute will serve as the Caribbean Branch of the US Cochrane Center (CBUSCC). The announcement took place after a launch event at the UWI Regional Headquarters, Mona on June 6. Mark Wilson and Jeremy Grimshaw, CEO and Chairman of Cochrane Canada respectively, attended the ceremony along with Luis Gabriel Cuervo of the Pan American Health Organization, a longtime partner of the Cochrane Collaboration. EVIPNET



International Meeting on Ethnicity, Indigenous People, and Health Evidence Construction, Bolivia, May 8-10, 2013

The meeting, organized by PAHO's Gender, Cultural Diversity, Human Rights and Bioethics Office, was held in Santa Cruz de la Sierra. Evelina Chapman presented the strategy of the evidence-informed policy network (EVIPNet) and talked about how the use of evidences can improve the health of indigenous groups. Evelina also discussed the most pressing challenges in the construction of health evidences from an ethnicity and indigenous people perspective.



International Conference and High Level Meeting on Chronic Kidney Disease, El Salvador, April 24-25, 2013

The International Conference on Chronic Kidney Disease that took place in San Salvador had as main objective to update the entire national, subregional, and other invited countries' evidence, besides that of Central America and the Dominican Republic. The conference stressed the importance of generating policies that are informed by evidence and clinical guidelines, and technical assistance to accomplish the predetermined objectives was offered. Evelina Chapman, at the request of COMISCA, was invited to contribute to the harmonization of research processes. The meeting was an opportunity to discuss the possible establishment of EVIPNet in El Salvador. Official site.





EVIPNet workshop with COMISCA, Costa Rica April 1-5, 2013

The Executive Secretariat of the Council of Ministers of Health from Central America and Dominican Republic (SE-COMISCA), held an EVIPNet workshops in collaboration with PAHO Research Promotion and Development for teams of the COMISCA countries. The workshop, organized by Evelina Chapman and Ruben Grajeda, PAHO, discussed Evidences for the Elaboration of Evidence Briefs for Policies and Deliberative Dialogues. One of the topics covered in the workshop was chronic kidney disease from nontraditional cause, a serious concern in Central America. The Health Minister, Dr. Daisy Corrales, adjourned the workshop, which coincided with the celebration for the World Health Day. 

Interventions for American Cutaneous and Mucocutaneous Leishmaniasis: A Systematic Review Update


