# **HOT SPOT**

# **Scholarships for Health**



Mexico, through CONACYT and AMEXCID, has allocated the first scholarships for postgraduate studies in health disciplines, as a result of the OAS-PAHO agreement signed in 2014 to facilitate the advancement of the Policy on Research for Health. With the opening of health and agriculture, applications grew substantially (increase of about 350%); 21 professionals applied (10% of the total scholarships); 8 will benefit

from health related scholarships mainly for Doctorate and Masters or specializations. The successful applicants were from Argentina, Bolivia, Colombia, Dominican Republic, El Salvador, United States and Panamá. In 2014 Brazil offered 75 scholarships for postgraduate health programs to applicants from 18 OAS Member States through Grupo Coimbra of Brazilian Universities. The program has been expanded for 2015 and 115 scholarships will be offered; the deadline for applications is 15 July, 2015 and the call is open to students from OAS Member States. # **INCLEN revamps its networking INCLEN meets after a long gap**

The International Clinical Epidemiology Network (INCLEN) organized the 21st Global Meeting in February 2015 as part of their new strategic plan to rejuvenate the network and initiate collaborative multicentric studies. The meeting was held at the University of Witwatersrand, Johannesburg-South Africa and the theme focused on using "Collaborative Research for Achieving Sustainable Development Goals". Members of Board of Trustees and Regional Advisory Boards joined 53 other participants and called for funding and strategies to attract bright young researchers to sustain the organization.

## TDR postgraduate training program



Seven universities (3 in Africa, 2 in Asia, 1 in Latin America, and 1 in the Middle East) from low- and middle-income countries <u>have been selected to host the TDR international postgraduate training program</u>, which will integrate implementation research in order to improve health throughout their respective

regions. As a result, over 200 Masters and Doctoral degrees will be awarded to students of low- and middle-income countries over the next four years. The first round of grants will begin during this academic year; however, each university will involve its own application process. For the Americas the coordination of this project will be done through the Universidad de Antioquia, in Medellin, Colombia.

# In the Secretariat Strategic Partnerships WHO's use of research evidence in nutrition guidelines

To improve the competencies and support for human resources involved in research for health, the Department of Nutrition for Health and Development of the World Health Organization (WHO) through its coordination for Evidence and Programme Guidance is collaborating with PAHO's Office of Knowledge Bioethics and Research. WHO, the Micronutrient Initiative and the Latin American Society of Nutrition are training a group of professionals to strength core professional skills and advance the Policy on Research for Health. Trainees acquire hands-on expertise and use scientific tools tailored to the contemporary global environment in nutrition global policy for sustainable health and development. The selected participants come from Ecuador/Brazil (Diana Estevez), Mexico (Mónica Flores Urrutia) and Barbados (Brian Payne). They are working at WHO for 4 months and will later join the Micronutrient

Initiative Headquarters in Canada and visit the WHO regional office for the Eastern Mediterranean for 3 months. PAHO is supporting a seminar with them to familiarize them with specific tools to advance the Policy on Research for Health, facilitate knowledge translation and better research governance, and their integration with regional and local initiatives and networks. Participants of this multidisciplinary training programme will also receive courses on search for literature, public speaking, policy implementation and equity, Cochrane systematic reviews of biomedical literature and evidence summaries to inform policy at Cornell University. Finally they will participate in the symposium of the Latin American Society of Nutrition, in the Dominican Republic, in November 2015.



# **EQUATOR Network presents at 4th World Conference on Research Integrity in Rio de Janeiro**

The EQUATOR Network, one of PAHO's strategic partners promoting transparency in research, research integrity and better reporting of research, had a prominent role at the 4th World Conference on Research Integrity in Rio de Janeiro, May 31 to June 3, 2015. ## **Grants for Health Programs Implementation**



The Pan American Health Organization (PAHO) and the Alliance for Health Policy and Systems Research (AHPSR) - World Health Organization (WHO) developed a country-focused program to support the implementation of technical cooperation projects in the region of the Americas. The objective of the initiative is to facilitate improvements in program implementation through implementation research that is embedded within existing processes in Latin America and the Caribbean.

During the first week of June, a workshop was

held in Rosario, Santa Fe where subsidies grantees had the opportunity to do a follow up on their programs results. Different representatives from Argentina, Brazil, Colombia, Chile, Mexico and Peru gave a presentation of their results. Dr. Ludovic Reveiz from the office of Knowledge Bioethics and Research at PAHO was the lead for this 2<sup>nd</sup> workshop that gives continuity to the grants initiative. # Advancing the Policy on Research for Health in Suriname

PAHO/WHO is supporting the authorities of Suriname in guiding the implementation of PAHO'S Policy on Research for Health and the development of its National Health Research System, including the establishment of baseline information to identify what is available, what needs to be strengthened, and what capacities and resources need to be developed.

In order to advance this process, Denis Ako-Arrey (PhD candidate) is working in the PAHO office's country office as a focal point for research policy implementation. He will conduct a mapping exercise and assessment of Suriname's National Health Research System to guide a needs assessment. He will organize policy recommendations based on PAHO's Policy on Research for Health and support technical cooperation and training activities working with academia, research institutes, government sector, NGOs and other relevant stakeholders to enhance the availability, accessibility and quality of research as well as health research knowledge translation activities. His findings will feed into <a href="Suriname's HRWeb">Suriname's HRWeb</a> page.

#### #saveCochraneCanada



Through its partnership with PAHO/WHO, the Canadian Cochrane Centre has been an asset to its citizens by providing high-quality information about how to produce and use meaningful research, and was accessed by people globally, especially from the Americas. With PAHO, the Center has produced 65 webinars reaching over 2600 connections (to rooms and individual participants) since 2012. Recordings have been used as reference materials over 40,000 times; webinars began in 2009 so the influence is even larger. The selection of the topics has considered the objectives of Policy on Research for Health issued in 2009. Support the Canadian

Featured at the conference will be a combination of EQUATOR and REWARD topics, a review of *The Lancet* Research Waste series, discussion surrounding improvement of research quality and efficiency, and derivation of a consensus statement and action plan for making progress against Research Waste series. Keynote speakers include Sir Iain Chalmers, Prof Doug Altman, and Prof Rustam Al-Shahi Salman, along with the Annual Equator Lecture presented by Dr Luis Gabriel Cuervo (PAHO). The <u>conference programme</u> will also feature an expert practical session for journal editors on reducing the number of unusable research articles.

# Meeting of WHO Regional Research leaders to follow on the observatory of research on innovation for health



Research advisors from WHO regional offices and Headquarters meet to retake the dialogue of coordination and harmonization that conducted to efficiency and that potentiated projects relevant to the Research for Health Policy. Focal points from six regional offices met under coordination of the Knowledge Management, Bioethics and Research, this kind of meetings used to be done with the WHO

Advisory Committee of Research for Health but stopped in 2010. The re-establishment of this dynamic under WHO's leadership is an opportunity to re-establish the team work and dynamics that brought harmonization and coordination to trans-regional initiatives of high impact, such as <a href="EVIPNet">EVIPNet</a>, regional support to WHO's Guideline Review Committee, the <a href="International Clinical Trial Registry Platform">International Clinical Trial Registry Platform</a>, the Strategy on Research for Health, and other strategic developments.

# Pan American Journal of Public Health



Workshop on writing scientific papers and scientific literature search in Argentina, 2015

As PAHO's scientific journal, the mission of the <u>Pan</u> <u>American Journal of Public Health</u> is to publish scientific evidence pertinent to the Organization Plan of Action and relevant to the countries. In this context, at the country level there is a need to strengthen the scientific writing skills and scientific literature search skills of researchers and authors.

In the last two years the Journal team along with the country counterparts has provided workshops on *How to write scientific papers* and *How to search scientific literature*. Examples include workshops in Peru (to researchers working on drug policies), Argentina/ Brazil/ Paraguay (to author's writing papers on leishmaniasis), the

Dominican Republic (authors, editors and researchers) and Argentina (same target audience). Initiatives are underway to further disseminate and share these workshops and related materials through virtual meetings and written methodologies.

# In memoriam

#### Dr. David Sackett



Widely recognized as the "father of evidence based medicine", Dr. David Sackett passed away on May 13, 2015 at the age of 80. Sackett grew up in a Chicago suburb and completed his medical training at the University of Illinois. Throughout his time with the US Public Health Service, he came across some epidemiologists, became fascinated with the interaction of epidemiology and clinical medicine, and soon came to derive the discipline today referred to

as "clinical epidemiology". In 1967, he joined the inaugural medical faculty at McMaster University's medical school as a professor. It was during this time he compiled a book entitled "Clinical Epidemiology: a Basic Science for Clinical Medicine", which has been guiding evidence-based medicine ever since. In 1994, he became the director of the Center for Evidence-Based Medicine at Oxford University, and soon after, the first chair of the Cochrane Collaboration. He retired in Canada in his last years of life, and is survived by his wife, four sons, and eight grandchildren.

#### Dr. Arturo Morillo

We are remembering <u>Professor Arturo Morillo MD</u> who passed away in April 2015 at the age of 90. A neurophysiologist by training, he served as a leader in many settings, including as a faculty member and Dean of Medicine at Universidad Javeriana in Colombia. He became the Executive Director of the International Clinical Epidemiology Network (INCLEN) from 1991 to 1996 and lead its expansion in low and middle income countries increasing the influence of clinical epidemiology and laying the grounds and human resources support that facilitated the expansion of evidence-informed health care and the growth of the Cochrane Collaboration. He is survived by his wife and children, three of whom are also researchers and who continue his legacy of leadership in research for health."
