#### REPORT ON THE COLLECTION OF ASSESSED CONTRIBUTIONS

- 1. The Director has the honor to present a report on the status of assessed contributions due from Members as of 31 July 2015. Collections are shown by Member States, Participating States, and Associate Members and by date of payment (See Annex A).
- 2. Total contributions received as of 31 July 2015 were US\$ 79,179,824<sup>1</sup> as compared to \$84,048,887 and \$68,991,064 received during the same periods in 2014 and 2013, respectively. Of the amount received this year, \$45,413,615 relates to 2015 assessments and \$33,766,209 relates to prior years.
- 3. In order to provide the 54th Directing Council with the latest information, an Addendum will be issued prior to the Session providing an update on the status of assessed contributions.
- 4. The balance of assessed contributions that remain due as of 31 July 2015 totals \$64,546,068 and is comprised of \$60,206,385 in current year assessments and \$4,339,683 pertaining to assessments for prior years.
- 5. The Organization continues to encourage the Member States to make prompt payment of their outstanding assessed contributions to ensure the efficient and effective implementation of its programs. As of 31 July 2015, no Member State is in arrears such that it can be subject to Article 6.B of the PAHO Constitution.
- 6. The Executive Committee at its 156th session considered the status of assessed contributions and adopted resolution CE156.R1, attached (see Annex B).

#### COLLECTION OF ASSESSED CONTRIBUTIONS

#### The 156th SESSION OF THE EXECUTIVE COMMITTEE,

Having considered the report of the Director on the collection of assessed contributions (Document CE156/20 and Add. I);

Noting that no Member State is in arrears in the payment of its assessed contributions to the extent that it can be subject to the application of Article 6.B of the Constitution of the Pan American Health Organization; and

Noting that 17 Member States have not made any payments towards their 2015 assessments,

#### **RESOLVES:**

- 1. To take note of the report of the Director on the collection of assessed contributions (Document CE156/20 and Add. I).
- 2. To thank the Member States for their commitment in meeting their financial obligations to the Organization by making efforts to pay their arrears of contributions.
- 3. To commend the Member States that have already made payments for 2015 and to urge the other Member States to pay all their outstanding contributions as soon as possible.
- 4. To request the Director to continue to inform the Member States of any balances due and to report to the Directing Council on the status of the collection of assessed contributions.

#### **PROPOSED RESOLUTION**

#### COLLECTION OF ASSESSED CONTRIBUTIONS

#### THE 54th DIRECTING COUNCIL,

Having considered the report of the Director on the collection of assessed contributions (Document CD54/15 and Add. I), and the concern expressed by the 156th Session of the Executive Committee with respect to the status of the collection of assessed contributions;

Noting that no Member State is in arrears such that it would be subject to Article 6.B of the PAHO Constitution.

#### **RESOLVES:**

- 1. To take note of the report of the Director on the collection of assessed contributions (Documents CD54/15 and Add. I).
- 2. To express appreciation to those Member States which have already made payments in 2015, and to urge all Members States in arrears to meet their financial obligations to the Organization in an expeditious manner.
- 3. To congratulate those Member States which have fully met their assessed obligations through 2015.
- 4. To compliment those Member States which have made significant payment efforts to reduce assessed contributions arrearages for prior years.

- 5. To request the Director to:
- a) continue to explore mechanisms that will increase the rate of collection of assessed contributions;
- b) advise the Executive Committee of Member States' compliance with their payment of assessed contribution commitments;
- c) report to the 55th Directing Council on the status of the collection of assessed contributions for 2016 and prior years.
