Confirmed case: a suspected case with any specific CHIK test (viral isolation, RT-PCR, Ig M, or four-fold increase of chikungunya specific antibodies titers) - PAHOICDC confirmed case definition available at www.paho.org/chikungunya.

"On March 3, 2017, the number of suspected cases increased from 175 to 170, based on the adjustments made by the Ministry of Health of Peru. On March 17, 2017, the number of confirmed cases decreased from 28 to 27, based on the adjustments made by the Ministry of Health of Peru.
