### Submissions to AG's Chambers-March 2018

- Public Health Amendment Bill 2017 –advocating for comprehensive legislation
- Proposal submitted to funding agency for support with policy and legislation formulation. (same pending)
- Public Health (Smoking Control) Regulations 2017-for substantive review and strengthening of smoking control regulations.









### M-POWER implementation

- Focus on MOW of the strategy: (Monitor, offer Help, Warn about Dangers)
- Current taxation 63.5%:
- Same calculated with a mixture of: Common External Tariff-45%
- Customs service charge: 6%
- VAT: 12.5%
- Seen as a bench mark for the rest of the OECS
- This is an indication that our tax mark up is a good place to start









### Revenue

- Increase prices through increased specific taxes.
- Ministry of Finance submitted representative to be represented on committee.

# SPECIFICATION FOR LABELLING OF TOBACCO PRODUCTS









## Mandatory Tobacco package labels In effect from August16, 2017

- Enforced by the Saint Lucia Bureau of Standards Noncompliance carries legal penalties
- Standards adopted by the SLBS in 2016 and enacted in 2017
- Manufacturers, distributers, importers, retailers & other entities shall (must) comply
- Every tobacco carton & package must bear the labels
- Name & Address of manufacturer, manufacturing date & batch number
- Health warnings on the package itself not the cellophane or wrapping









## Mandatory Tobacco package labels In effect from August16, 2017

- Back and front package warnings
- Graphic warnings covering 50% of the package whatever the shape
- Set of 8 health warnings to be evenly distributed within the stock
- Health warnings to be rotated, no warnings to be used for more than 16 months. Rotation schedule already set out in the standard. Two sets of eight health warnings
- Declaration on all packages must be bold in colour (eg black font on yellow background) and placed on the side of the package
- No deceptive labels









# Overview of 'The Box'

























### Presentation of 'The Box'

- The health warnings are to be depicted in individual packages of tobacco products in accordance in accordance with this standard shall be divided into 2 distinct sets.
- Health warnings Set A and Set B is being used alternatively in rotation.
- No set of warnings shall be utilized in the market for more than 16 months.
- The health warnings will be printed on the box; not on the cellophane or detachable outer packages of by adhesive labels.



The following text shall be used in the declaration area:

"Smoke from this product contains extremely addictive nicotine and toxic substances such as tar and carbon monoxide. No safe level of consumption exists for this product".
