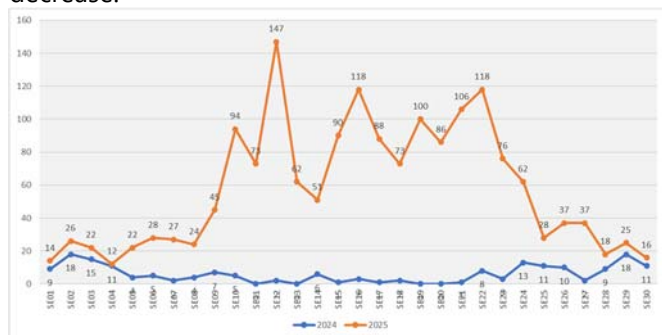
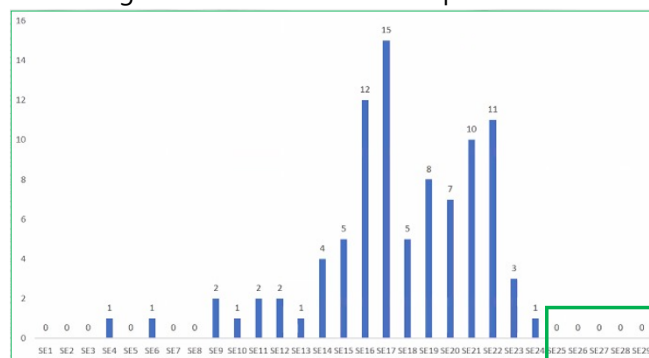


HIGHLIGHTS

- Newly suspected cholera cases are still reported weekly in both IDP sites and communities, despite a decrease in case. The ministry of Public Health and Population continues its response interventions with the support of partners, including PAHO/WHO, contributing to this decrease.



- No confirmed cholera cases have been reported countrywide over the past five weeks. Nevertheless, the ongoing response efforts to stop the spread of cholera should continue, including WASH interventions, notably ensuring access to safe water and improving hygiene & sanitation conditions. Efforts must be sustained to maintain gains and ensure further improvements.



Key figures as of July 26, 2025

1,287,593 million people are displaced across the country.¹
The vast majority living in host families (83%) and the remaining in **246 active** sites (17%).

620 445 migrants deported from the Dominican Republic²
(72.4% males, 19.7% females, 4.7% boys, 3.5% girls).

Situation updates

Cholera

During EpiWeek 30 (July 20-26, 2025), a total of **40** suspected cholera cases were reported nationwide, 16 in 4 communes in the Ouest department (14 in IDP sites), 1 in 1 commune in Artibonite, 7 in 1 commune in the Centre, 6 in 3 communes in Nippes, 6 in 1 commune in Nord and 4 in 2 communes in Sud-Est.

In addition, six communes continue to report high numbers of suspected cholera cases: **Saint-Raphael** (Nord), **Thomonde** (Centre), **Delmas**, **Port-au-Prince**, **Pétion-Ville** and **Cité Soleil** (Ouest).

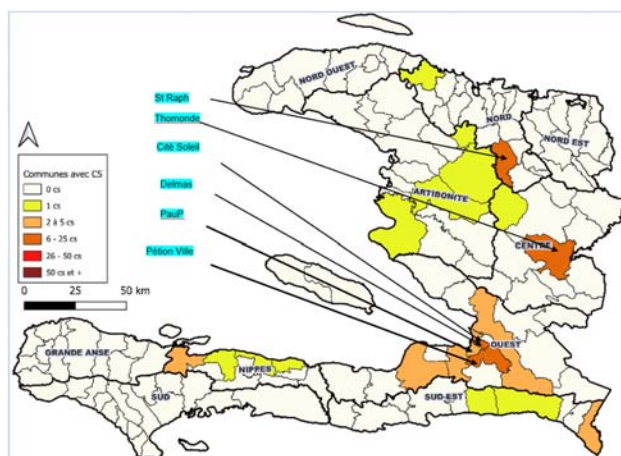
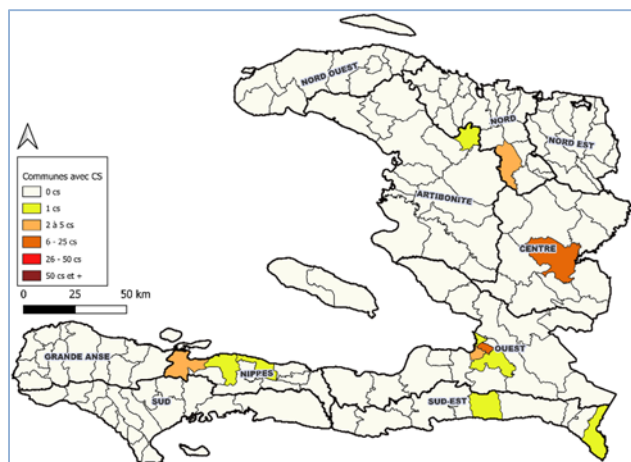


Figure 1: Six cholera hotspots⁷ as reported during EpiWeek 30 (July 20-26, 2025)

Response activities

Cholera

Epi Surveillance and case management

- **20 suspected cases** were admitted to acute diarrhea treatment centers (*CTDA, as per its acronym in French*) supported by PAHO/WHO during the last Epi Week 30 (July 20-26, 2025). No institutional deaths were reported.
- During EpiWeek 30, **30 samples** were collected and sent by surveillance teams/motorcycle-labs, with the support from PAHO/WHO, to the National Laboratory of Public Health (LNSP) for appropriate analysis, including 14 from 8 IDP sites in the metropolitan area of Port-au-Prince (7) and Léogâne (1).

WaSH & IPC, RCCE

During the EpiWeek, several activities were implemented in the following departments:

- **Centre**
 - With support from PAHO/WHO, the Health Directorate of the Centre department conducted awareness sessions on water treatment and cholera prevention in Thomonde targeting **2 225** people in the area. In addition, **500** persons received doxycycline chemoprophylaxis, **2 225 oral rehydration solutions (ORS)** were distributed, and 57 households and 23 latrines were decontaminated, **11 350** aquatab distributed, **22** handwashing stations installed, etc.
- **Nord**
 - PAHO/WHO and the Health Directorate of the Nord department conducted joint awareness sessions on water treatment and cholera prevention in the commune of Saint-Raphael targeting 151 people. Moreover, 13 persons received doxycycline chemoprophylaxis, **153 oral rehydration solutions (ORS)** were distributed, and 18 households and 6 latrines were decontaminated, **468** aquatab and **159 oral rehydration solutions (ORS)** distributed.

Displacement

During EpiWeek 30 (July 20-26, 2025), a total of **27 000 internally displaced persons** were assisted across 66 IDP sites in the metropolitan area of Port-au-Prince. Health Cluster partners – including PAHO/WHO, UNICEF, ALIMA, OIM, MDM Canada, IRC, UNFPA, ISPD, FADRHIS, PROFAMIL, MSF – provided services such as awareness sessions on key topics, clinical care, antenatal consultations, mental health and psychological support, referrals, deworming, vaccination, nutritional screening, and skilled birth attendance in health facilities and through mobile clinics despite challenges related to the global funding reduction, limited access, and insecurity, particularly in the metropolitan area of Port-au-Prince, Artibonite and Centre. In addition, 21 IDP site representatives were trained on first aid by the ICRC in collaboration with the Haitian Red Cross in 7 IDP sites.

Gaps, constraints and priorities

Gaps and constraints

- Challenges affecting the referral system (such as irregular checkpoints, etc.), are particularly impacting pregnant women and children under 5 in need in the commune of Carrefour, metropolitan area of Port-au-Prince.
- Access and security challenges continue to hamper the health response, especially in the metropolitan area of Port-au-Prince, lower Artibonite and plateau Central area.
- Limited access to safe water, poor hygiene conditions, and inadequate sanitation -particularly in IDP sites- are exacerbating health risks.
- Limited accountability to affected people, especially in IDP sites.

Priorities

- Advocate for operational referral system in zones inaccessible due to insecurity, particularly in the commune of Carrefour.
- Enhance the accountability to affected people through innovative approaches in the Haitian context, engage partners flexibility to amend their implementation upon the feedback received, etc.
- Improve water supply, and hygiene and sanitation conditions, particularly in IDP sites.
